10 AN ACT concerning employment; providing for a fair share represen-
11 tation fee to be paid to certain labor organizations under certain cir-
12 cumstances; relating to procedures, rights and duties; amending K.S.A.
13 44-803 and repealing the existing section.

15 *Be it enacted by the Legislature of the State of Kansas:*

16 Section 1. K.S.A. 44-803 is hereby amended to read as follows: 44-
17 803. (a) Employees shall have the right to self-organization, to form, join,
18 or assist labor organizations, to bargain collectively through representa-
19 tives of their own choosing, and to engage in concerted activities, for the
20 purpose of collective bargaining or other mutual aid or protection, and
21 such employees shall also have the right to refrain from any or all such
22 activities.

23 (b) *Any labor organization that is certified or formally recognized as*
24 *the exclusive bargaining agent under the national labor relations act and*
25 *required by such federal act to represent all members of the bargaining*
26 *unit to the same extent, regardless of whether they are members of the*
27 *labor organization, may assess a fair share representation fee to nonmem-*
28 *ber employees. Such fair share representation fee shall apply to represen-*
29 *tation services provided to such nonmember employee pursuant to a spe-*
30 *cific request made by such nonmember employee by the labor*
31 *organization in any matter relating to an individual grievance concerning*
32 *such nonmember employee.*

33 (c) *The fair share representation fee for employees, who are not mem-*
34 *bers of the labor organization, shall not exceed the actual cost of repre-*
35 *senting such nonmember employees in any matter relating to an individ-*
36 *ual grievance concerning such nonmember employee as provided in*
37 *subsection (b). Such service fee shall not include the cost of any additional*
38 *benefits provided to union members through their dues.*

39 (d) *Failure of a nonmember employee to pay such nonmember em-*
40 *ployee's fair share representation fee, as provided in this section, shall*
41 *give the labor organization the right to bring an action, in any court of*
42 *competent jurisdiction, for the payment of such service fee, together with*
43 *costs and attorney fees. An employee's failure to pay such service fee shall*

1 *not prejudice the employee's right to continued employment with the em-*
2 *ployer. It is unlawful for a labor organization or an employer to discrim-*
3 *inate against any employee in any way because of the failure of an em-*
4 *ployee to pay the fair share representation fee. Payment or nonpayment*
5 *of the fair share representation fee shall in no way be a condition of*
6 *employment.*

7 Sec. 2. K.S.A. 44-803 is hereby repealed.

8 Sec. 3. This act shall take effect and be in force from and after its
9 publication in the statute book.
