10 AN ACT concerning certain school districts; relating to the assessed val-
11 uation thereof.

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. (a) As used in this section:

15 (1) "School district" means unified school district No. 507 and unified
16 school district No. 374.

17 (2) "Property" means the following described property, and improve-
18 ments thereon, comprised of 1,120 acres, more or less, located in Haskell
19 county: All of Section 34, Township 29 South, Range 33 West and the
20 West 1/2 of Section 3, Township 30 South, Range 33 West and the North-
21 east Quarter of Section 3, Township 30 South, Range 33 West.

22 (3) "State aid" means general state aid, supplemental general state
23 aid, capital improvements state aid, capital outlay state aid and any other
24 state aid paid, distributed or allocated to school districts under the school
25 district finance and quality performance act or other law, and any other
26 state aid paid, distributed or allocated to school districts on the basis of
27 the assessed valuation of school districts.

28 (b) For the purposes of computing the assessed valuation of school
29 districts for the payment, distribution or allocation of state aid and the
30 levying of school taxes, 1/2 of the assessed valuation of such property shall
31 be assigned to each of the school districts.

32 (c) The provisions of this section shall not apply if the property is not
33 or ceases to be used for the production of ethanol.

34 **Sec. 2. (a) As used in this section:**

35 (1) **"School district" means unified school district No. 404, uni-**
36 **fied school district No. 493, unified school district No. 499 and uni-**
37 **fied school district No. 508.**

38 (2) **"Property" means any property, and improvements thereon,**
39 **comprising a racetrack gaming facility or lottery gaming facility**
40 **under the Kansas expanded lottery act located in Cherokee county.**

41 (3) **"State aid" means general state aid, supplemental general**
42 **state aid, capital improvements state aid, capital outlay state aid**
43 **and any other state aid paid, distributed or allocated to school dis-**

1 *tricts under the school district finance and quality performance act*
2 *or other law, and any other state aid paid, distributed or allocated*
3 *to school districts on the basis of the assessed valuation of school*
4 *districts.*

5 *(b) For the purposes of computing the assessed valuation of*
6 *school districts for the payment, distribution or allocation of state*
7 *aid and the levying of school taxes, $\frac{1}{4}$ of the assessed valuation of*
8 *such property shall be assigned to each of the school districts.*

9 *(c) The provisions of this section shall not apply if the property*
10 *is not or ceases to be used as a racetrack gaming facility or a lottery*
11 *gaming facility under the Kansas expanded lottery act.*

12 Sec. 3. This act shall take effect and be in force from and after its
13 publication in the statute book.
