12 AN ACT concerning income taxation; providing a checkoff for Kansas
13 military emergency relief; **providing a checkoff for breast cancer**
14 **research.**

16 *Be it enacted by the Legislature of the State of Kansas:*

17 Section 1. (a) For all tax years commencing after December 31,
18 2005, each Kansas state individual income tax return form shall contain
19 a designation as follows:

20 Kansas Military Emergency Relief Fund. Check if you wish to donate,
21 in addition to your tax liability, or designate from your refund, _____\$1,
22 _____\$5, _____\$10 or \$ _____.

23 (b) The director of taxation of the department of revenue shall de-
24 termine annually the total amount designated for contribution to the Kan-
25 sas military emergency relief fund pursuant to subsection (a) and shall
26 report such amount to the state treasurer who shall credit the entire
27 amount thereof to the Kansas military emergency relief fund which fund
28 is hereby established in the state treasury. All moneys deposited in such
29 fund shall be used ~~solely~~ for the purpose of helping military families
30 defray the costs of food, housing, utilities and medical services incurred
31 while a member of the family is on active military duty **or for other**
32 **services associated with support of Kansas military personnel and**
33 **military families.** In the case where donations are made pursuant to
34 subsection (a), the director shall remit the entire amount thereof to the
35 state treasurer who shall credit the same to such fund. All expenditures
36 from such fund shall be made in accordance with appropriation acts upon
37 warrants of the director of accounts and reports issued pursuant to vouch-
38 ers approved by the adjutant general's office.

39 **Sec. 2. (a) For all tax years commencing after December 31,**
40 **2005, each Kansas individual income tax return form shall contain**
41 **a designation as follows:**

2 ***(b) The director of taxation of the department of revenue shall***
3 ***determine annually the total amount designated for contribution to***
4 ***the Kansas breast cancer research fund pursuant to subsection (a)***
5 ***and shall report such amount to the state treasurer who shall credit***
6 ***the entire amount thereof to the Kansas breast cancer research fund.***
7 ***Such fund is hereby established in the state treasury and shall be***
8 ***administered by the university of Kansas cancer center. In the case***
9 ***where donations are made pursuant to subsection (a), the director***
10 ***shall remit the entire amount thereof to the state treasurer in ac-***
11 ***cordance with the provisions of K.S.A. 75-4215, and amendments***
12 ***thereto. Upon receipt of such remittance the state treasurer shall***
13 ***deposit the entire amount in the state treasury to the credit of such***
14 ***fund. All expenditures from such fund shall be for the university of***
15 ***Kansas cancer center.***

16 ***(c) The instructions accompanying the individual income tax re-***
17 ***turn shall include a description of the Kansas breast cancer research***
18 ***fund, the purpose for which the fund was created and a statement***
19 ***specifying that such moneys shall be used to conduct research re-***
20 ***lating to the prevention, treatment and cure of breast cancer. Such***
21 ***description and statement shall be approved by the university of***
22 ***Kansas cancer center.***

23 ***(d) All moneys deposited in such fund shall be used by the uni-***
24 ***versity of Kansas cancer center to conduct research relating to the***
25 ***prevention, treatment and cure of breast cancer. Moneys in such***
26 ***fund shall not be used for the funding of administrative personnel***
27 ***or positions. Moneys deposited in such fund shall be used in col-***
28 ***laboration with other research institutions including, but not lim-***
29 ***ited to, members of the midwest cancer alliance and faculty at state***
30 ***educational institutions. Contributions to the Kansas breast cancer***
31 ***research fund shall be deemed in addition and supplemental to any***
32 ***funding that would otherwise be appropriated to the university of***
33 ***Kansas cancer center for the purposes specified in this act.***

34 ***(e) On or before February 1 of each year, the university of Kan-***
35 ***sas cancer center shall submit a report to the committee on assess-***
36 ***ment and taxation and committee on ways and means of the senate***
37 ***of the state of Kansas and the committee on taxation and committee***
38 ***on appropriations of the house of representatives of the state of***
39 ***Kansas reviewing and evaluating all expended moneys expended***
40 ***from the Kansas breast cancer research fund to conduct research***
41 ***relating to the purposes specified in this act. Representatives of the***
42 ***cancer center shall appear before the committees specified in this***
43 ***section if so requested.***
