12 AN ACT establishing the Kansas technical college and vocational edu-
13 cation school commission; concerning duties and related matters.

15 *Be it enacted by the Legislature of the State of Kansas:*

16 Section 1. (a) There is hereby established the Kansas technical col-
17 lege and vocational education school commission, which shall be com-
18 posed of ~~seven~~ **the following** members ~~appointed as follows:~~

19 (1) One member shall be a member of the state board of regents and
20 shall be selected by the state board of regents;

21 (2) one member shall be a ~~member of the governing board of a Kan-~~
22 sas technical college **president** and shall be selected by the state board
23 of regents;

24 (3) one member shall be a person selected by the governor who shall
25 serve as chairperson of the commission; ~~and~~

26 (4) the speaker and minority leader of the house of representatives
27 and the president and minority leader of the senate shall each select one
28 member of the commission; **and**

29 **(5) The president of the board of regents shall be an ex-officio,**
30 **nonvoting member of the commission.**

31 **(b) In making such selections, the governor and legislative lead-**
32 **ers shall give consideration to persons representing businesses, in-**
33 **dustry, and instructional staff of such schools and colleges.**

34 ~~(b c)~~ **(c)** The commission shall undertake a study of the governance,
35 funding **performance** and the mission of Kansas technical colleges and
36 vocational education schools. **The commission shall review and con-**
37 **sider recommendations of the board of regents.**

38 **(e d)** On or before January 1, 2007, the commission shall submit its
39 first report of the commission's activities and **legislative** recommenda-
40 tions regarding governance, funding **performance** and the mission of
41 Kansas technical colleges and vocational education schools. On or before
42 January 1, 2008, the commission shall submit its final report on such
43 matters **and legislative recommendations.** The commission shall be

1 abolished after submission of its final report.

2 ~~(d e)~~ Members serving on the commission shall receive compensa-
3 tion, subsistence allowances and expenses as provided in K.S.A. 75-3223
4 and amendments thereto from appropriations for the legislature **board**
5 **of regents**.

6 ~~(e) The staff of the legislative research department and revisor of~~
7 ~~statutes office shall provide staff support to the commission.~~

8 **(f) Staff assistance shall resources of the state board of regents**
9 **shall be provided to the commission and coordinated by the state**
10 **board of regents. Other staff assistance may be provided by the**
11 ***office of the revisor of statutes, the legislative research department***
12 ***and the division of legislative administrative services as may be***
13 ***directed by the legislative coordinating council.***

14 Sec. 2. This act shall take effect and be in force from and after its
15 publication in the statute book.
