9 AN ACT relating to property taxation; providing for the cancellation of
10 certain uncollected taxes.

12 *Be it enacted by the Legislature of the State of Kansas:*

13 Section 1. Notwithstanding any provision of law to the contrary, for
14 the purpose of facilitating the sale or transfer of the Kuhlman Diecasting
15 property located at 16400 Mission Road, Johnson county, Kansas, the
16 board of county commissioners of Johnson county, upon a majority vote,
17 may cancel all or a part thereof, of any uncollected real estate taxes and
18 penalties on such property. Such property is legally described as:

19 THAT PART OF THE EAST HALF OF THE SOUTHEAST QUAR-
20 TER OF SECTION 16, TOWNSHIP 14, RANGE 25, IN JOHNSON
21 COUNTY, KANSAS, DESCRIBED AS FOLLOWS: BEGINNING AT
22 THE NORTHEAST CORNER OF SAID SOUTHEAST QUARTER;
23 THENCE WEST ALONG THE NORTH LINE OF SAID SOUTH-
24 EAST QUARTER TO THE NORTHWEST CORNER OF THE EAST
25 HALF OF SAID SOUTHEAST QUARTER; THENCE SOUTH ON
26 THE LINE RUNNING NORTH AND SOUTH THROUGH THE
27 CENTER OF SAID QUARTER SECTION 441 FEET, CROSSING
28 THE BIG BLUE RIVER, TO A POINT 6 FEET SOUTH OF THE
29 SOUTH BANK OF SAID RIVER; THENCE SOUTHERLY AND
30 FOLLOWING THE SOUTHERLY AND WESTERLY BANK OF
31 SAID RIVER AND 6 FEET DISTANT THEREFROM TO THE CEN-
32 TER OF WHAT IS KNOWN AS CAMP BRANCH; THENCE DOWN
33 THE CENTER OF SAID BRANCH TO THE CENTER OF SAID BIG
34 BLUE RIVER; THENCE FOLLOWING DOWN THE CENTER OF
35 SAID RIVER TO THE EAST LINE OF SAID SECTION 16; THENCE
36 NORTH ALONG THE EAST LINE OF SAID SECTION TO THE
37 PLACE OF BEGINNING; BUT EXCEPTING THEREFROM THE
38 RIGHT OF WAY OF THE MISSOURI PACIFIC RAILROAD; AND
39 ALSO EXCEPTING THEREFROM ALL THAT PART OF THE
40 NORTH 154 FEET OF SAID SOUTHEAST QUARTER WHICH LIES
41 EAST OF SAID MISSOURI PACIFIC RAILROAD RIGHT OF WAY.

42 Sec. 2. This act shall take effect and be in force from and after its
43 publication in the statute book.
