9 AN ACT concerning license plates; providing for a combat veteran and
10 legion of merit decals; amending K.S.A. 2008 Supp. 8-1,156 and re-
11 pealing the existing section.

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. K.S.A. 2008 Supp. 8-1,156 is hereby amended to read as
15 follows: 8-1,156. (a) Any person issued a license plate under the provisions
16 of K.S.A. 8-1,140 or 8-1,146, and amendments thereto, upon submitting
17 satisfactory proof to the director of vehicles in accordance with rules and
18 regulations adopted by the secretary, that such person was awarded a
19 silver star or bronze star medal by the United States government, may
20 request a decal for each license plate indicating the person was a recipient
21 of a silver star or bronze star medal.

22 (b) ~~On and after January 1, 2006,~~ Any person issued a license plate
23 under the provisions of K.S.A. 8-1,140 or 8-1,146, and amendments
24 thereto, upon submitting satisfactory proof to the director of vehicles in
25 accordance with rules and regulations adopted by the secretary, that such
26 person was awarded *the legion of merit*, a combat medical badge, army
27 combat infantry badge, navy/marine corps combat action ribbon, army
28 distinguished service cross, navy cross, air force cross or distinguished
29 flying cross by the United States government, may request a decal for
30 each license plate indicating the person was a recipient of *the legion of*
31 *merit*, a combat medical badge, army combat infantry badge, navy/marine
32 corps combat action ribbon, army distinguished service cross, navy cross,
33 air force cross or distinguished flying cross.

34 (c) *Not more than two decals authorized by this section shall be af-*
35 *fixed to any one license plate issued under K.S.A. 8-1,140 or 8-1,146, and*
36 *amendments thereto.*

37 (d) *Any person issued a license plate under the provisions of article*
38 *1 of chapter 8 of the Kansas Statutes Annotated, upon submitting satis-*
39 *factory proof to the director of vehicles in accordance with rules and*
40 *regulations adopted by the secretary, that such person is a combat vet-*
41 *eran, may request a decal for each license plate indicating the person is*
42 *a combat veteran.*

43 (e) A fee of \$2 shall be paid for each decal issued. The director of

1 vehicles shall design such decals. Such decals shall be affixed to the license
2 plate in the location required by the director. ~~Not more than two decals~~
3 ~~authorized by this section shall be affixed to any one license plate.~~
4 Sec. 2. K.S.A. 2008 Supp. 8-1,156 is hereby repealed.
5 Sec. 3. This act shall take effect and be in force from and after its
6 publication in the statute book.
