FIRST DAY

SENATE CHAMBER, TOPEKA, KANSAS Monday, January 8, 2001—2:00 p.m.

In accordance with the provisions of the Constitution of the State of Kansas and K.S.A. 46-142(d), the 2001 Session of the Kansas Legislature was called to order by Secretary of State Ron Thornburgh.

Secretary Thornburgh introduced the Rev. Fred S. Hollomon, Pastor of the Highland Park Southern Baptist Church, Topeka, Kansas, who will again serve as the Senate Chaplain, and delivered the following invocation:

REMARKS BY PRESIDENT KERR

On behalf of my fellow senators, I thank Chief Justice McFarland for her assistance in today's ceremony. I also want to recognize and thank the many family members and friends present today without whom most of us would not or could not be here.

I am greatly honored to have been elected President of the Kansas Senate. In executing the duties of this office, I will seek your help, your guidance and your considerable patience. Abraham Lincoln once said, "Nearly all men can stand adversity, but if you want to test a man's character, give him power."

I am well aware that any power vested in this position exists only because you and the people of Kansas have chosen to make it so. Any misuse or abuse of that power and it will be quickly dissipated.

Since the Session of 1869, many talented and articulate people have labored in these lovely Senate chambers providing democratic, representative government for our state. In order for this group of forty to be remembered by those who follow us as truly exceptional, much will be demanded of us. We will begin each day with a prayer in the expectation that the almighty will guide our words and deeds. We will end each day with the announcement that we will meet again on the morrow in the hope that each successive day will be still more productive and beneficial to our constituents.

So it will be for the next 89 days. Perhaps it might be helpful to keep in mind this additional admonition from President Lincoln. "You cannot bring about prosperity by discouraging thrift. You cannot strengthen the weak by weakening the strong. You cannot help the wage earner by pulling down the wage payer. You cannot further the brotherhood of man by encouraging class hatred. You cannot build character and courage by taking away man's initiative and independence. You cannot help men permanently by doing what they could and should do for themselves."

REMARKS BY MINORITY LEADER HENSLEY

Thank you, Mr President. I want to express my appreciation to our chaplain Fred Holloman for observing a moment of silence for our friend and colleague, the late Janice Hardenburger, and for his condolences to the Mark Gilstrap family on the death of Mark's mother.

In the preparation for any new term, there are always very difficult challenges. The greatest challenge for me was scraping off from my front windshield my old parking sticker to be replaced with my new one!

Mr. President, on behalf of the minority party, I congratulate you, the Vice President, the Majority Leader, and the other elected leadership of the majority party.

Also on behalf of the minority party, I want to say we look forward to working with all of the members of the majority party. We pledge cooperation but know that there will be those times when we will disagree.

The members of the minority party also want to congratulate and welcome the new members of the Kansas State Senate - both those of you who have been elected for the first time to the Kansas Legislature, and those of you who came over from serving in the Kansas House of Representatives.

Mr. President, for me, the beginning of this session marks a special anniversary in my legislative tenure. This is the beginning of my 25th session.

My tenure is surpassed only by the Senator from Segwick, the dean of the Legislature, Senator Paul Feleciano, who begins his 29th session.

I point this out not to boast, or to lecture you on the pros and cons of legislative term limits, but to recognize that whether this is your first or 25th session, what we did here today is still a very exciting and awesome experience for us and for our families as well.

And, even more exciting and awesome is that now we take on a great responsibility. We have been entrusted by the people of our district to represent them in this great legislative body.

The margin between the majority and minority was determined by the results of the November 7th election. It goes without saying for Democrats in Kansas, those results were very disappointing.

We put our time and effort into the campaigns because we believe that a competitive two-party system of government is good for the political process and good for the people of Kansas. And there were a lot of good citizens who put their name and reputation on the line to run for state senate on the Democratic ticket.

But, now that the election is over, and oaths have been administered, we begin the legislative process of debating and deciding public policy. That debate and those decisions will be very important and will focus on a multitude of issues ranging from the quality of our water, to how we fund our schools, to how we draw the lines for our Congressional and legislative districts.

An institution such as this Senate is guided by basic principles, and I am reminded that a member of Congress once stated: "Basic principles must endure if we are to have an effective institution, and chief among these is the belief that the principle of minority rights is equal in dignity and in importance and in no way subservient to the principle of majority rule."

That Congressman was the former Republican Minority Leader Bob Michel of Illinois when he made a similar speech on the first day of a new term.

I am also reminded by what President Bond said on this very day four years ago, "We labor under a set of rules and tradition that call us to treat each other with respect and courtesy even when we strongly disagree."

Mr. President, the members of the minority party pledge our respect for the basic principle of majority rule. In return, we ask for your respect for our role and rights in this process.

Senate Concurrent Resolution No. 1602-

By Special Committee on Utilities

A CONCURRENT RESOLUTION urging the Federal Energy Regulatory Commission to investigate certain natural gas prices.

WHEREAS, The price of natural gas delivered to consumers in the area of the Hugoton Gas Field is comparable to the price of the same natural gas delivered to consumers hundreds of miles away in the Midwest and Upper Midwest; and

WHEREAS, The cost of transporting natural gas for sale to consumers at long distances should logically be reflected in higher prices for those customers than for customers in or near areas where natural gas is produced: Now, therefore,

Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That the Federal Energy Regulatory Commission (FERC) be urged to investigate why the cost of natural gas sold to Kansas consumers is comparable to the price of natural gas sold to consumers at great distances; and

Be it further resolved: That the Secretary of State be directed to send an enrolled copy of this resolution to the Federal Energy Regulatory Commission.

MESSAGE FROM THE GOVERNOR

August 16, 2000

To the Senate of the State of Kansas:
