SENATE CHAMBER, TOPEKA, KANSAS Monday, February 5, 2001—2:30 p.m.

**SB 222.** An act concerning the Kansas air quality act; relating to permits; amending K.S.A. 2000 Supp. 65-3008b and repealing the existing section, by Committee on Utilities.

SB 223, An act concerning livestock; enacting the competitive livestock markets act; prohibiting certain acts and prescribing certain penalties, by Committee on Agriculture.

- **SB 224**, An act concerning electric utilities; providing for competitive bidding for certain power contracts, by Committee on Utilities.
- **SB 225**, An act relating to driving under the influence of alcohol or drugs; concerning the surrender of drivers' licenses; amending K.S.A. 2000 Supp. 8-1002 and repealing the existing section, by Committee on Transportation.
- **SB 226.** An act concerning telecommunications; relating to enhanced wireless 911 service, by Committee on Commerce.
- **SB 227**, An act concerning state purchasing; providing a mechanism for the submittal of on-line bids, by Committee on Commerce.
- **SB 228**, An act concerning real property; relating to transfer upon the death of the owner; filing a notification of interest in title by an heir, by Senator Haley.
- SB 229, An act concerning crimes and punishment; relating to cruelty to animals; amending K.S.A. 2000 Supp. 21-4310 and repealing the existing section, by Senator Haley.
- **SB 230**, An act concerning crimes, criminal procedure and penalties; relating to sentencing; hate crimes; amending K.S.A. 2000 Supp. 21-4716 and repealing the existing section, by Senator Haley.
- **SB 231**, An act establishing the family development account program and family development account reserve fund, by Senator Haley.
- **SB 232**, An act relating to income taxation; increasing the earned income tax credit; amending K.S.A. 2000 Supp. 79-32,205 and repealing the existing section, by Senators Hensley, Barone, Downey, Feleciano, Gilstrap, Gooch, Goodwin, Haley, Lee and Steineger.
- **SB 233**, An act relating to sales taxation; exempting certain sales of natural gas from local sales taxes; amending K.S.A. 12-189a and repealing the existing section, by Senators Allen, Adkins, Barnett, Brownlee, Clark, Haley, Harrington, Jackson, Jenkins, Jordan, O'Connor, Praeger, Pugh, Schodorf, Steineger, Tyson, Umbarger, Vratil and Wagle.
- **SB 234**, An act concerning school district finance; relating to local option budgets; affecting the definitions of state prescribed percentage and district prescribed percentage; amending K.S.A. 2000 Supp. 72-6433 and repealing the existing section, by Senator Vratil.
- **SB 235**, An act concerning crimes and punishment; relating to domestic battery; amending K.S.A. 2000 Supp. 21-3412 and repealing the existing section, by Committee on Judiciary.
- **SB 236**, An act concerning the code of civil procedure; relating to garnishment; amending K.S.A. 2000 Supp. 60-205 and repealing the existing section; also repealing K.S.A. 60-714, 60-715, 60-716 and 60-720 and K.S.A. 2000 Supp. 60-717, 60-718, 60-726 and 60-728 and Forms No. 27 and 28 in the appendix of forms following K.S.A. 60-269, by Committee on Judiciary.

#### INTRODUCTION OF HOUSE BILLS AND CONCURRENT RESOLUTIONS

HB 2010, HB 2029, HB 2065, HB 2099, HB 2149 were thereupon introduced and read by title.

### REPORTS OF STANDING COMMITTEES

Committee on **Education** recommends **SB 25** be passed.

Also SB 9, SB 24 be passed and, because the committee is of the opinion that the bills are of a noncontroversial nature, be placed on the consent calendar.

SB 78 be amended on page 1, in line 35, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

Committee on Public Health and Welfare recommends SB 50 be passed.

Committee on **Utilities** recommends **SB 3** be amended on page 1, in line 15, by striking all before "motor-vehicle" and inserting "All bulk"; also in line 15, after "purchased" by inserting: "by any state agency, as defined in K.S.A. 75-3701, and amendments thereto,"; in line 16, before "motor" where it appears for the first time, by inserting "state-owned"; also in line 16, by striking all after "vehicles"; in line 17, by striking all before "shall"; in line 18, after the period, by inserting: "However, such state agencies shall not be required to purchase bulk motor-vehicle fuel blends containing at least 10% ethanol, if the cost of such fuel exceeds the cost of regular unleaded gasoline by \$.10 per gallon.

(c) Where available under current state purchasing agreements, individual motor-vehicle fuel purchases for state-owned motor vehicles shall be of motor-vehicle fuel blends containing at least 10% ethanol."; and the bill be passed as amended.

Also SB 4 be amended on page 1, in line 17, by striking "Not less than 80% by volume of all" and inserting "All bulk"; also in line 17, after "purchased" by inserting: "by any state agency, as defined by K.S.A. 75-3701, and amendments thereto,"; in line 18, before "motor" where it appears for the first time, by inserting "state-owned"; also in line 18, by striking all after "vehicles"; in line 19, by striking all before "shall"; in line 20, after the period, by inserting: "However, such state agencies shall not be required to purchase bulk diesel fuel containing at least 2% biodiesel, if the cost of such fuel exceeds the cost of regular diesel fuel by \$.10 per gallon.

(c) Where available under current state purchasing agreements, individual diesel fuel purchases for state-owned motor vehicles shall be of diesel fuel blends containing at least 2% biodiesel."; and the bill be passed as amended.
