TWENTY-FIRST DAY

SENATE CHAMBER, TOPEKA, KANSAS Tuesday, February 6, 2001—2:30 p.m.

INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senators Oleen, Adkins, Allen, Barnett, Barone, Brownlee, Brungardt, Clark, Corbin, Donovan, Downey, Emler, Feleciano, Gilstrap, Gooch, Goodwin, Haley, Harrington, Hensley, Huelskamp, Jackson, Jenkins, Jordan, Kerr, Lee, Lyon, Morris, O'Connor, Praeger, Pugh, Salmans, Schmidt, Schodorf, Steineger, Taddiken, Teichman, Tyson, Umbarger, Vratil and Wagle introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1815-

A RESOLUTION recognizing February 6 as Ronald Reagan Day.

WHEREAS, President Ronald Wilson Reagan, a man of humble background, worked throughout his life serving freedom and advancing the public good, having been employed as an entertainer, union leader, corporate spokesman, governor of California and president of the United States; and

WHEREAS, Ronald Reagan served with honor and distinction for two terms as the 40th president of the United States of America; the second of which he was victorious in 49 of the 50 states in the general election, earning the confidence of three-fifths of the electorate—a record unsurpassed in the history of American presidential elections; and

WHEREAS, During Mr. Reagan's presidency he worked in a bipartisan manner to enact his bold agenda of restoring accountability and common sense to government which led to an unprecedented economic expansion and opportunity for millions of Americans; and

WHEREAS, Mr. Reagan's commitment to an active social policy agenda for the nation's children helped lower crime and drug use in our neighborhoods; and

WHEREAS, President Reagan's commitment to our armed forces contributed to the restoration of pride in America, her values and those cherished by the free world, and prepared America's armed forces to win the Gulf War; and

WHEREAS, President Reagan's vision of "peace through strength" led to the end of the Cold War and the ultimate demise of the Soviet Union, guaranteeing basic human rights for millions of people; and

WHEREAS, On February 6, 2001, Ronald Reagan will have reached the age of ninety years, thus becoming both the oldest active and oldest former President in the history of our nation: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we recognize February 6, 2001, as Ronald Reagan Day; and

Be it further resolved: That the Secretary of the Senate be directed to send three enrolled copies of this resolution to Grover G. Norquist, President, Ronald Reagan Legacy Project, 1920 L. Street NW, Suite 200, Washington, D.C. 20036.

On emergency motion of Senator Donovan \widetilde{SR} 1815 was adopted unanimously.

REPORTS OF STANDING COMMITTEES

Committee on Agriculture recommends $SB\ 60$ be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

Also **SCR 1605** be amended on page 1, in line 15, by striking "One regulation subject to the moratorium is a" and inserting "The"; in line 17, after "Kansas" by inserting: "should be subject to the moratorium";

On page 2, in line 34, after "withdraw" by inserting: "or withdraw and review and revise"; in line 35, after "Resolution" by inserting: "to fully accommodate the concerns expressed by Kansans during the public hearings conducted by the Environmental Protection Agency"; and the concurrent resolution be adopted as amended.

Committee on **Federal and State Affairs** recommends **SB 133** be amended on page 1, by striking all in lines 16 through 22 and inserting:

"Section 1. K.S.A. 35-204 is hereby amended to read as follows: 35-204. (a) The last Friday in April of each year is hereby designated as Arbor Day in the state of Kansas.

(b) Each year the governor of this state is hereby authorized and directed to issue annually may issue a proclamation calling upon our state officials to display the United States flag on all state and school buildings and declaring the last Friday in March to be Arbor Day and inviting the people of the state to observe the day in schools and other suitable places, with appropriate ceremonies."; and the bill be passed as amended.

Committee on Ways and Means recommends SB 31 be passed.

Also **HB 2022** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

On motion of Senator Oleen the Senate adjourned until $2:30~\mathrm{p.m.}$, Wednesday, February 7,2001.
