SENATE CHAMBER, TOPEKA, KANSAS Thursday, February 8, 2001—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with forty senators present.

President Kerr introduced as guest chaplain, Rev. William Templeton, Mount Carmel Missionary Baptist Church, Topeka, Ks., who delivered the invocation:

Almighty and eternal God, who has made known to us through Thy Son, Jesus Christ, your concern for the government and for human relationships: Grant, as we pause in this hallowed moment, that the spirit of prayer and reverence for Thy Name may prevail in this place.

REPORTS OF STANDING COMMITTEES

Committee on Judiciary recommends SB 74, SB 98 be passed.

Also **SB 66** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

SB 97 be amended on page 1, in line 17, by striking ", by" and inserting "or in the absence of the governor, the lieutenant governor, or in the absence of both,"; in line 18, by striking all after "governor" the first time it appears; in line 19, by striking "electronic signature" and inserting "in writing"; and the bill be passed as amended.

Committee on **Elections and Local Government** recommends **SB 107** be amended on page 1, in line 37, by striking "providing" and inserting: "proving in the district court"; in line 39, after "ordinance" by inserting a comma; also in line 39, after "resolution" by inserting a comma;

On page 2, in line 2, after "ordinance" by inserting a comma; also in line 2, after "resolution" by inserting a comma; after line 11, by inserting the following:

"(e) Any action challenging the validity of the form of a question in a petition shall be filed in the district court within 20 days after such petition has been filed."; and the bill be passed as amended.

Committee on **Ways and Means** recommends **SB 242** be amended on page 4, in line 35, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.
