THIRTY-EIGHTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Friday, March 2, 2001—9:30 a.m.

The Senate was called to order by Vice-President Sandy Praeger. The roll was called with thirty-five senators present. Senators Downey, Harrington, Lyon, Vratil and Wagle were excused. Invocation by Chaplain Fred S. Hollomon:
