**HB 2820**, An act concerning vocational education; relating to determining credit hour equivalencies; amending K.S.A. 2001 Supp. 72-4412 and repealing the existing section, by Committee on Higher Education.

**HB 2821**, An act concerning vocational education; relating to tuition rates for postsecondary students; amending K.S.A. 72-4433 and repealing the existing section, by Committee on Higher Education.

 $HB\ 2822$ , An act concerning the Kansas lottery; authorizing the use of electronic gaming devices; amending K.S.A. 2001 Supp. 74-8702 and 74-8710 and repealing the existing sections, by Committee on Tourism.

**HB 2823**, An act relating to the division of vehicles; concerning driver's licenses and identification cards; selective service registration requirements; amending K.S.A. 8-240 and 8-1324 and repealing the existing sections, by Representative Cook.

**HB 2824**, An act concerning school district financing; relating to school facilities weighting; amending K.S.A. 2001 Supp. 72-6407 and repealing the existing section, by Representative Vickrey.

**HB 2825**, An act concerning public employer-employee relationships; relating to resolution of certain impasses; amending K.S.A. 75-4332 and repealing the existing section, by Committee on Federal and State Affairs.

**HB 2826**, An act concerning eigarette retailers; relating to contracts with suppliers; prohibiting certain terms thereof, by Committee on Federal and State Affairs.

**HB 2827**, An act relating to sales taxation; exempting purchases of state contracted substance abuse prevention service providers therefrom; amending K.S.A. 2001 Supp. 79-3606 and repealing the existing section, by Committee on Taxation.

**HB 2828**, An act relating to sales taxation; authorizing Douglas county to impose a countywide tax for certain purposes; amending K.S.A. 12-187, 12-189 and 12-192 and repealing the existing sections; also repealing K.S.A. 12-189e, by Committee on Taxation.

**HB 2829**, An act concerning parking on certain state property; amending K.S.A. 75-4506 and 75-4508 and repealing the existing sections, by Committee on Appropriations.

**HB 2830**, An act concerning environmental contamination of real property; providing for prohibition or restriction of activities on and use of such property for certain purposes, by Committee on Environment.

**HB 2831**, An act concerning community colleges; relating to interlocal agreements; amending K.S.A. 2001 Supp. 71-201 and repealing the existing section, by Committee on Higher Education.
