A RESOLUTION memorializing the Congress of the United States to maintain needed medical services at the Dwight D. Eisenhower Department of Veterans Affairs Medical Center in Leavenworth and the Colmery-O'Neil Department of Veterans Affairs Medical Center in Topeka.

WHEREAS, The Veterans Affairs Eastern Kansas Health Care System is comprised of the Dwight D. Eisenhower Veterans Affairs Medical Center in Leavenworth, Kansas, and the Colmery-O'Neil Veterans Affairs Medical Center in Topeka, Kansas. The Veterans Affairs Eastern Kansas Health Care System offers significant inpatient and outpatient services with a focus on primary care, psychiatric treatment and extended care supported by nursing home care units and a domiciliary. The Veterans Affairs Eastern Kansas Health Care System's primary service area consists of 49 counties in Kansas and Missouri. The veteran population in these counties totals over 104,000. In fiscal year 2000, the Veterans Affairs Eastern Kansas Health Care System provided care to approximately 34,000 unique patients. The Veterans Affairs Eastern Kansas Health Care System has a long history of service to veterans; and

WHEREAS, The city of Leavenworth provided the land and considerable financial assistance to secure the establishment of the Western Branch, National Home for Disabled Volunteer Soldiers in 1884. In its early days it served as a home for "old soldiers". The home became a part of the Veterans Administration in 1930 as its mission changed from housing to provision of medical services to veterans of military service. Since World War II, the Center has served admirably the medical needs of an aging veteran population in Eastern Kansas and Western Missouri, and with the reduction in availability of medical services at active military installations, the Center is providing increasingly medical care for active duty military personnel; and

WHÉREAS, The Colmery-O'Neil Veterans Affairs Medical Center was built in 1942 as an Army hospital. At the end of World War II, it was the first Army hospital to be transferred to the Veterans Administration. On January 11, 1946, it was officially dedicated as a Veterans Administration Hospital and offered treatment to veterans with psychiatric illnesses. The hospital has a long standing affiliation with the Karl Menninger School of Psychiatry. Through the years, the medical center has evolved into a comprehensive health care facility meeting the needs of veterans who have served their country; and

WHEREAS, While Department of Veterans Affairs information on future plans are not known, there is an ongoing insidious erosion of service capabilities at these facilities. This continues even though nearly 35,000 active and retired military personnel and a substantial number of veterans have made their homes in the Leavenworth community in order to use the facilities of Fort Leavenworth and the Dwight D. Eisenhower Veterans Affairs Medical Center: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we memorialize the Congress of the United States of the need to continue to provide the fine services which have been provided previously to our veterans at the Dwight D. Eisenhower Department of Veterans Affairs Medical Center in Leavenworth and the Colmery-O'Neil Department of Veterans Affairs Medical Center in Topeka; and

Be it further resolved: That the Chief Clerk of the House of Representatives be directed to provide an enrolled copy of this resolution to the President of the United States Senate, the Speaker of the United States House of Representatives, the Director of the Department of Veterans Affairs and to each member of the Kansas congressional delegation.

#### EXPLANATION OF VOTE

Mr. Speaker: **SB 402** fails to create the innovative independent schools for which federal funding has been appropriated. The intent of Federal Charter School legislation is to provide school choice to constituents within a public school district. Such schools are not intended to be alternative schools within a public school district as **SB 402** requires. This bill also fails to define any mechanism for funding these charter schools after the 3-year federal funding grants expire. I vote no on **SB 402**.—Karen Divita-Johnson

At least annually, the secretary of administration shall prepare a report setting forth all suggestions received from state employees under the state employee suggestion program and shall submit such report to the division of post audit and the legislative research department.
- (g) Salary bonus payments under the Kansas savings incentive program shall be made only to state employees who submit workable suggestions under the state employee suggestion program for saving state moneys or for increased efficiencies or other economies in the operations of one or more state agencies.";

On page 1, in the title, in line 11, preceding "amending" by inserting "state employee suggestion program;"

Also, on motion of Rep. Novascone **SB 429** be amended on page 1, following line 15, by inserting the following:

"New Section 1. (a) Notwithstanding any other provision of law, no state officer or employee shall be reimbursed for actual and necessary expenses incurred in the performance of such officer's or employee's duties from a governmental entity if such officer or employee is receiving a per diem subsistence allowance or any other type of reimbursement from another governmental entity for the reimbursement of expenses incurred in the performance of such officer's or employee's duties.

(b) As used in this section, "governmental entity" means an executive, legislative or judicial agency, department, board, commission, authority, institution or instrumentality of the federal government or of a state or of a county, municipality or other political subdivision of a state.":

Renumber the remaining sections accordingly;

In the title, on page 1, in line 11, after the semicolon by inserting "prohibiting certain reimbursment;"; and **SB 429** be passed as amended.

- (b) Every school bus shall be equipped with red visual signals meeting the requirements of subsection (a) of K.S.A. 8-1730, and amendments thereto, which may be actuated by the driver of the school bus whenever but only whenever such vehicle is stopped on the highway for the purpose of receiving or discharging school children. A school bus driver shall not actuate the special visual signals:
- (1) At intersections or other places where traffic is controlled by traffic-control signals or police officers; or
  - (2) in designated school bus loading areas where the bus is entirely off the roadway.
- (c) Every school bus shall bear upon the front and rear thereof plainly visible. (1) signs containing the words "school bus" in letters not less than eight inches in height; and (2) decals stating "Warning, \$100 Fine for Passing Stopped School Bus with Red Lights Flashing and Stop Sign Activated".
- When a school bus is being operated upon a highway for purposes other than the actual transportation of children either to or from school or to or from interschool or intraschool functions or activities, or for maintenance, repair or storage purposes all markings thereon indicating "school bus" shall be covered or concealed.
- (d) The driver of a vehicle upon a highway with separate roadways need not stop upon meeting or passing a school bus which is on a different roadway or when upon a controlled-access highway and the school bus is stopped in a loading zone which is a part of or adjacent to such highway and where pedestrians are not permitted to cross the roadway.
- (e) The provisions of this section shall be subject to the provisions contained in K.S.A. 8-2009a, and amendments thereto.";
