SENATE CHAMBER, TOPEKA, KANSAS Wednesday, February 20, 2002—2:30 p.m.

The Senate was called to order by President Dave Kerr.

#### EXPLANATION OF VOTE

MR. PRESIDENT: I vote "no" on **SB 402** because a good charter school bill should allow for true competition and entrepreneurship in order to foster the very best educational opportunities for all students. This legislation has a few "crumbs" of improvement to our current law. But it does not deal with the fatal flaw that makes Kansas's charter school law

one of the worst in the nation. Also it actually exacerbates the problem by increasing local veto power over any charter school effort.—Kay O'Connor

#### EXPLANATION OF VOTE

MR. PRESIDENT: I vote no on SB 407.

While the idea of keg registration is an admirable one, this bill enacts new legislation that is damaging to the concept of local control.

Any law passed by a city or county, even if it is more stringent than this legislation, would be rendered moot by this bill. That is a dangerous idea. I cannot support a bill that places all power in Topeka, especially not when most Kansans prefer local control and more responsibility for local governments than for state government.

MR. PRESIDENT, I would be more supportive of this bill if it granted local communities the authority to, if they see fit, enact local rules regarding keg registration.

We are perfectly within our rights to require keg registration, and I am supportive of such a measure, but we are overstepping our authority when we limit the authority of our local governments. This is but another example of "big government."—JIM BARONE

Committee on **Financial İnstitutions and Insurance** recommends **SB 469** be amended on page 3, in line 12, by striking "the amount" and inserting "except as provided by paragraph (6) of this subsection, the rate"; in line 13, following "be", by inserting "at least"; also in line 13, by striking "amount" and inserting "rate"; in line 19, by striking the period and inserting a semicolon; following line 19, by inserting the following:

"(5) the entity shall elect to participate for a minimum of three consecutive years in the state health care benefits program; and

(6) the commission may authorize an entity to pay less than the state rate for the employee coverage for no more than three years and no more than five years for dependent coverage on the condition that the entity elects to participate for at least three consecutive years after first paying the state rate for employee coverage.";
