SENATE CHAMBER, TOPEKA, KANSAS Friday, March 1, 2002—9:30 a.m.

The Senate was called to order by President Dave Kerr.

PRESENTATION OF PETITIONS

The following petitions were presented, read and filed:

SP 2, by Senator Lana Oleen: A petition Urging the Kansas Legislature to protect the Geary and Riley County Community of Interest when drawing new Congressional boundaries, signed by Robert W. Clowe and 44 other citizens of Junction City, Kansas.

SP 3, by Senator James Barnett: A petition Urging the Kansas Legislature to protect the Geary and Riley County Community of Interest when drawing new congressional boundaries, signed by Evelyn Avery and 22 other citizens of Junction City and Milford, Kansas.

POINT OF PERSONAL PRIVILEGE

Mr. President, Senator Hensley and Senate colleagues:

This morning I am honored; humbled; personally elevated to present a former member of this Chamber....my father, George W. Haley, now of Silver Spring, Maryland.

Much of what I am today is directly attributable to this one man. His values, including being a responsible and loving father (as he is to me and to my sister, Anne...an attorney in L.A.); a committed husband (as he is to my mother, Doris and I try to be to my wife, Michelle!); and to treat every person you meet with tolerance and patience and to persevere with goals and ideals you hold dear and one day they will be accomplished...Mr. President these are my father's values and values which I have inherited through him.

A role model to myself and countless other young people, George Haley after graduating high school, served in the U.S. Air Force and graduated from Morehouse College, in Atlanta, Georgia (as I later would) and law school (as I later would) though he attended the University of Arkansas.

He served as Assistant City Attorney of Kansas City, Kansas and as a lawyer in private practice before becoming the first Black person elected to the Kansas Senate in 1964; despite being Republican in strongly Democratic Wyandotte County. After serving in the Senate, he would go on to serve in different capacities during five presidential administrations (Presidents Nixon, Ford, Reagan, Bush and Clinton) culminating as the U.S. Ambassador to the Gambia, West Africa. (where our family history was traced to Kunta Kinteh by his brother, author Alex Haley's, book *Roots*).

Before Roots, Uncle Alex wrote of a man in an article called *The Man Who Wouldn't Quit* published in the Reader's Digest.

This story, which chronicled the struggles of one man to overcome adversity and hatred to finish law school, was the story of my father. I have learned from him to tolerate and to persevere and to forgive and to be patient and to love.

I am, again, honored and blessed to have him as my father and role model and humbly ask the Senate in joining me to welcome him....Ambassador George W. Haley.

The President withdrew **SB 529** from the Calendar under the heading General Orders, and rereferred the bill to the Committee on Elections and Local Government.

The President withdrew **SB 411** from the Calendar under the heading General Orders, and referred the bill to the Committee on Ways and Means.

SB 624, An act relating to motor vehicles; providing for the issuance of certain distinctive license plates; amending K.S.A. 8-1,141 and repealing the existing section.
