INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senators Jackson, Hensley and Jenkins introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1844-

A RESOLUTION congratulating and commending the Topeka Lutheran School girls basketball team and Coach Walt Malone for winning third place at the National Lutheran Tournament of Champions.

WHEREAS, The Topeka Lutheran girls basketball team was undefeated the last two seasons in the Topeka Parochial League and the Parochial League Tournament. Last summer, the Topeka Lutheran School girls won 10 games with 0 losses in the Washburn Summer Basketball League. In addition to the Parochial League Tournament, the Topeka Lutheran School girls won the Annual Topeka Lutheran Invitational Tournament and the St. John's - Alma Preseason Tournament two consecutive years. They also won the Holy Cross Tournament in Emma, Missouri, as a newcomer to the tournament; and

WHEREAS, After a perfect 24 - 0 season during 2001-2002, which included wins over public, private and parochial school teams from Kansas, Missouri and Oklahoma, the Topeka Lutheran School girls were invited to the National Lutheran Tournament of Champions sponsored by the Lutheran Basketball Association of America, Inc. and held at Valparaiso University from March 21 to 24, 2002. The National Tournament included 24 teams from throughout the United States; and

WHEREAS, At the national tournament, the Topeka Lutheran School girls received a bye the first round. In second round play, they defeated a team from Heartland, Michigan. In the third round, they defeated a team from Wheaton, Illinois. In the semi-finals, the Topeka Lutheran School girls lost by 4 points in overtime to a team from Cedar Rapids, Iowa. The Topeka Lutheran School team bounced back from their only defeat of the season by winning the third place championship game by 9 points, defeating a team from Williamsburg, Iowa. Two Topeka Lutheran School players, Jamie Stinson and Angela Wiseman, were named to the All-Tournament Team; and

WHEREAS, Members of the Topeka Lutheran School girls basketball team were: Eighth graders, Jessica Berry, Christy Weems, Angela Wiseman and Jamie Stinson and seventh graders, Elise Bruns, Rachael Rost, Stephanie Lange and one sixth grader, Alisha Bolz. For tournaments, the team was joined by seventh graders Elizabeth Dale, Josie Berry, Melissa Powell, Chelsey Rogers and Mikayla Khalil. The Head Coach was Walt Malone. The Assistant Coaches were David Bruns and Jim Stinson; and

WHEREAS, The members of this outstanding basketball team have received national recognition for their fine sportsmanship and athletic abilities; and

WHEREAS, The success of this team was due to its excellent teamwork, strong competitive spirit and determination to win. The team also had the enthusiastic support of the school's administrators, the faculty, the students and the players' parents: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That the Topeka Lutheran School girls basketball team and Coach Malone be congratulated and commended for winning third place at the National Lutheran Tournament of Champions and for their success during the past two basketball seasons; and

WHEREAS, The award is sponsored by Emporia State University and is funded by the Trusler Foundation, patrons of the award and Emporia State University; and

WHEREAS, The 50th Anniversary of the William Allen White Children's Book Award is to be celebrated at Emporia on October 5, 2002: Now, therefore,

- (2) the minority leader of the senate or the minority leader of the senate's designee and one additional member appointed by the minority leader of the senate who shall be a landowner who owns at least 160 acres and is principally engaged in production agriculture;

- (3) the chairman of the senate committee on natural resources or the chairman of the senate committee on natural resources' designee provided that such designee is a member of the legislature of the state of Kansas;
- (4) the speaker of the house of representatives or the speaker of the house of representative's designee, and two additional members appointed by the speaker of the house of representatives, two of whom shall be landowners who own at least 160 acres of Kansas farm or ranch land and are principally engaged in production agriculture;
- (5) the minority leader of the house of representatives or the minority leader of the house of representative's designee and one additional member appointed by the minority leader of the house of representatives who shall be a landowner who owns at least 160 acres and is principally engaged in production agriculture;
- (6) the chairman of the house committee on environment or the chairman of the house committee on environment's designee provided that such designee is a member of the legislature of the state of Kansas; and
- (7) three members appointed by the governor, at least two of which shall be landowners who own at least 160 acres of Kansas farm or ranch land and are principally engaged in production agriculture.
 - (c) The following shall be nonvoting advisors to the members of the alliance:
 - (1) The secretary of wildlife and parks or the secretary's designee;
 - 2) the secretary of agriculture or the secretary's designee;
- (3) the executive director of the state conservation commission or the executive director's designee;
 - (4) the secretary of health and environment or the secretary's designee;
 - (5) the director of the Kansas water office or the director's designee;
 - (6) the state forester or the state forester's designee;
- (7) the secretary of commerce and housing or the secretary of commerce and housing's designee;
 - (8) the president of the Kansas farm bureau or the president's designee; and
 - 9) the president of the Kansas livestock association or the president's designee.
- (d) Officers making appointments pursuant to subsection (b) shall consult and coordinate among themselves in making the appointments in order to achieve a membership that represents a balance of knowledge and experience among interests in natural resources, environmental interests and related economic interests, including parks and recreation, soil and water conservation, travel and tourism, economic development, agriculture, outdoor recreation, landowners and homeowners, fish and wildlife, forest resources, prairie and grassland resources and municipalities. At least two such members shall represent environmental interests. In making the appointments, the officers shall solicit and allow an opportunity for recommendations by interested groups and individual citizens.
- New Sec. 7. (a) The alliance shall develop a vision for utilizing the state's natural resources to assure economic development, a healthy environment, proper protection of natural resources, opportunities for natural resource and environmental education and quality of life for Kansas families and individual citizens. In developing the vision, the alliance shall:
- (1) Conduct public hearings across the state to seek citizen input and provide information to the public;
- (2) seek input from state and local governmental agencies;
- (3) examine the state's current natural resource programs;
- (4) consider the impact of the state's natural resources and programs on economic development and the environment;
- (5) examine the state's current and future resource needs, recognizing the basic American freedom of private ownership of land and the landowner's right to private property protection pursuant to K.S.A. 77-701 et seq., and amendments thereto;
- (6) expand voluntary public or private partnerships that support and implement the vision; and
- (7) develop goals and establish priorities for attaining the vision, including, but not limited to, goals and priorities for outdoor recreation, tourism, economic development, natural resource and environmental education, quality of life, water quality, water supplies,

fish and wildlife resources, prairie and grassland resources, forest resources, parks and lakes, wetlands and riparian areas, soil and water conservation and air quality.

(b) The alliance shall submit a preliminary report of its activities and recommendations to the governor and the legislature on or before May 1, 2003, and shall submit a final report and recommendations to the governor and legislature on or before December 1, 2003.

New Sec. 8. (a) The alliance shall meet at least once each calendar quarter. The first meeting shall be called by the governor, at which time the alliance shall elect a chairperson and vice-chairperson. Thereafter, the alliance shall meet on call of the chairperson or on written request of a majority of the members. The alliance may hold its meetings at such times and at such places within the state as the members determine appropriate.

- (b) The alliance shall be attached to the state conservation commission as a part thereof. All budgeting, purchasing and related management functions of the alliance shall be administered by the executive director of the state conservation commission. The executive director of the state conservation commission shall provide office and meeting space and such clerical and other staff assistance as may be necessary to assist the alliance in carrying out its powers, duties and functions under this act.
- (c) Members of the alliance specified in subsection (b) of section 6, and amendments thereto, shall receive compensation, subsistence allowances, mileage and other expenses as provided in K.S.A. 75-3223, and amendments thereto.";

If the physician, licensed physician assistant or registered professional nurse refuses to perform such physical examination the prosecuting attorney is hereby empowered to seek a mandatory injunction against such physician, licensed physician assistant or registered professional nurse to enforce the provisions of this act. Any refusal by a physician, licensed physician assistant or registered professional nurse to perform an examination which has been requested pursuant to this section shall be reported by the county or district attorney to the state board of healing arts or the board of nursing, whichever is applicable, for appropriate disciplinary action. The department of health and environment, in cooperation with the Kansas bureau of investigation, shall establish procedures for gathering evidence pursuant to this section. A minor may consent to examination under this section. Such consent is not subject to disaffirmance because of

minority, and consent of parent or guardian of the minor is not required for such examination. The hospital or medical facility shall give written notice to the parent or guardian of a minor that such an examination has taken place.

(b) Costs of conducting an examination of a victim as herein provided including the costs of the sexual assault evidence collection kits shall be charged to and paid by the county where the alleged offense was committed. Such county may charge the defendant for the costs paid herein as court costs assessed pursuant to K.S.A. 28-172a or 28-172c, and amendments thereto.";

- (3) the district requesting the transfer of territory is obligated to operate or maintain one or more dikes, levees or other flood control works previously constructed by the United States army corps of engineers or other agencies of the United States government on the territory requested for transfer, which have been completed and turned over to the requesting drainage district for the purpose of maintaining and operating any dikes, levees or other flood control works heretofore or hereafter constructed for the purpose of protecting such drainage from floods;
- (4) contain a prayer that the territory described in such petition be transferred from one drainage district named therein to another drainage district named therein; and
 - (5) contain any other information in support of the proposed transfer.
- (c) Whenever a petition in conformity to subsection (b), signed by the board of directors of one or more of the affected drainage districts shall be presented to the board of county commissioners of Shawnee county, Kansas, it shall be the duty of such board of county commissioners forthwith to fix a time for the hearing of such petition and to cause the county clerk to give notice thereof at least five days before the date fixed for the hearing by one publication in some newspaper published and of general circulation in the county.
- (d) At the time set for the hearing of the petition as provided in subsection (b), the board of county commissioners of Shawnee county, Kansas shall first ascertain and determine whether notice has been given of the time of hearing as required by this act. If the board of county commissioners of Shawnee county, Kansas determines that such notice has been given, such board of county commissioners shall make a written finding of that fact and commence a public hearing to determine whether the petition should be granted.
- (e) At the hearing, the county commission of Shawnee county, Kansas shall take testimony from all persons interested in the proposed transfer of territory and any other evidence relevant to the issue.
- (1) Except as provided in paragraph (2), if such board of county commissioners, determines that the petition conforms to the requirements of this act, and that the allegations of the petition are true, then the board of county commissioners shall make a finding and decision to that effect. Such decision shall declare the territory described in the petition to be detached from the one drainage district, naming it, and to be attached to the other drainage district, naming it, and fix the date that such transfer shall become effective.
