EXPLANATION OF VOTE

MR. PRESIDENT: I vote no on **S Sub for Sub HB 3012** as amended by the Senate Committee of the Whole. I believe this map unnecessarily divides an important community of interest comprised of the counties of southeast Kansas. Southeast Kansas is an important region of our state with unique cultural, economic and political characteristics. We should not do harm to that community and its citizens by placing parts of it within each of the four Kansas congressional districts. Southeast Kansas deserves better.—DAVID ADKINS

Mr. President: As a Democrat, not a Republican, I completely concur with and wholeheartly endorse the remarks of the Senator from Montgomery.—Jim Barone

MR. PRESIDENT: The congressional district map embodied in **S Sub for Sub HB 3012** meets all the constitutional requirements needed for a legal redistricting map. The three constitutional requirements are contiguity, compactness, and a low population deviation. The contiguity requirement is easily met in this map. The compactness of the districts in **S Sub for Sub HB 3012** is very similar to the compactness of the current congressional districts, which was reviewed by a federal court ten years ago. The population deviation in **S Sub for Sub HB 3012** is the lowest population deviation ever proposed for a congressional map of Kansas. Recent federal court rulings make it a necessity to go to the extra step of reaching nearly absolute zero population deviation from district to district. **S Sub for Sub HB 3012** thus meets all the necessary constitutional requirements of redistricting.—TIM HUELSKAMP

PROTEST

MR. PRESIDENT, I hereby exercise my right under Article 2, Section 10, of the Kansas Constitution to protest Senate Substitute for Substitute for House Bill 3012. This bill is the Senate's attempt to fulfill its decennial obligation under the United States Constitution to adjust the boundaries of congressional districts to ensure every citizen's vote is afforded equal protection under the law.

The bill as recommended by the Senate Reapportionment Committee met that obligation. Unfortunately, the substitute amendment that was initially rejected and then narrowly adopted by the Senate Committee of the Whole does not.

The new map now proposed in this bill meets neither the requirements of the Constitution, nor the requirements of our redistricting guidelines, nor the requirements of good public policy or common sense. On its face, this map is a grotesque gerrymander that only a political operative could love. Indeed, the map's proponents stated during Senate floor debate that this map does satisfy the interests of two of the four current members of the Kansas congressional delegation and the interests of the Republican party hierarchy in Washington, D.C. I am a Republican. But my passion for our citizens exceeds my passion for my party. This map ignores the interests of the people of Kansas and is contrary to our state Constitution's declaration in Article 1, Section 2, that "[a]ll political power is inherent in the people, and all free governments are founded on their authority, and are instituted for their equal protection and benefit."

This map needlessly divides voting precincts. This map needlessly moves from one district to another far more counties and citizens than necessary. But, most importantly, this map completely disregards strong and obvious communities of interest for the purpose of diluting the voting strength of certain Kansas citizens because of their political beliefs, their relative lack of political power to defend their interests, and their economic status.

The worst, though not the only, example of this complete disregard is in Southeast Kansas. During the year-long work of the Senate Reapportionment Committee and the House Committee on Redistricting, numerous Kansans testified that Southeast Kansas, which comprises at least the nine counties from Woodson County east and from Woodson County south and which sometimes is described to include other nearby counties, is a unique area of the state with strong common interests. An advocacy organization for the rights of disabled citizens testified that having Southeast Kansas in a single congressional district was important to protect the rights of their clients. The regional economic-development organization for Southeast Kansas testified that keeping the nine counties together was important to permit strengthening the region's economy. At least four newspapers and numerous citizens and citizen organizations in the region have expressed sentiment similar to that published by The Iola Register on February 20, 2002. That editorial stated succinctly that the concepts embodied in this map "have ripped SEK (Southeast Kansas) into four parts and tossed each fragment into a separate congressional district, stripping our region of any influence in Washington for the next 10 years."

Southeast Kansas is the poorest region in the state. My home county of Montgomery ranked 91st of our 105 counties in per capita income in 1999, and Montgomery County can be aptly described as the "rich kid in the neighborhood." Its poorer neighbors include Labette, Cherokee, Neosho, Wilson, Woodson, Greenwood, Elk, Bourbon and Chautauqua counties. In light of the important role of federal programs and funds in combating poverty and promoting economic progress, effective federal representation is vital to the Southeast Kansas region. The citizens in these counties wish to work together to improve their economic condition and to alleviate many of the social ills that can accompany poverty. These citizens are entitled to pursue a betterment of their condition; that is one of their "inalienable natural rights" guaranteed by Article 1, Section 1, of the Kansas Constitution. But the proposed map denies that right to these citizens by dividing the 10 counties mentioned in this paragraph into three separate congressional districts and thereby diluting the voice of the region's citizens in each of those districts to the point of ineffectiveness.

The citizens of Southeast Kansas, who have only three senators in our 40-member senate, lacked the political power to defend their rights in the legislative process. The history of

America is the history of finding balance between the will of the majority and the rights of the minority. I am hopeful that this flawed map will not survive the legislative process. But if it does, I am hopeful a court of competent jurisdiction will fulfill its duty to protect the constitutional rights of the minority against the tyranny of the majority and will find this map in violation of the constitutional rights of Kansas citizens.

Therefore, I protest this legislation and vote no.—Derek Schmidt

WHEREAS, The Kansas Legislature, in section 1 of chapter 278 of the 1982 Session Laws of Kansas, authorized interstate highway I-470 from the east Topeka interchange of the Kansas turnpike to its intersection with interstate highway I-70 west of Topeka to be designated as "the Dr. Martin Luther King Jr. memorial highway." Markers have been placed along the highway right-of-way to properly indicate this designation, and such designation is so known and appreciated by many residents of the Topeka community; and

WHEREAS, The 20th anniversary of the designation of the Dr. Martin Luther King, Jr. memorial highway is being celebrated in Topeka on Sunday, April 28, on the south steps of the Kansas Statehouse. The event is sponsored by the Black History Month Observance Founders Commission and the Kansas Dr. Martin Luther King Memorial Anniversary Commission. Activities include an I-470 parade and motorcade, a proclamation, resolution, remarks, keynote address, church services, poetry reading and drill team exhibitions; and

WHEREAS, Mrs. Coretta Scott King sends the following message to the people of Kansas: On behalf of the King family and the board of directors and trustees of the Martin Luther King Jr. Center for Nonviolent Social Change, let me extend to all of the people of Kansas my warmest greetings and most heartfelt congratulations on the 20th anniversary of the official dedication of the Dr. Martin Luther King Jr. Memorial Highway. It is deeply gratifying that people of good will of all races remember and honor his life and work for justice and social decency. Your naming this highway after Martin Luther King Jr. serves as a reminder to the entire nation that his dream of a beloved community is alive and well in the heartland of America. By carefully choosing which heroes and heroines to honor, a society begins to shape its history and its destiny. In this spirit, the Dr. Martin Luther King Jr. Memorial Highway brings us one step closer to fulfilling the American dream of brotherhood, peace and prosperity for all of our people; and

WHEREAS, Earlier related activities were, as sponsored by the Black History Month Founder's Commission on March 20 at the Topeka-Shawnee County Public Library, an American Women History Month Celebration and the 150th Anniversary Celebration of Uncle Tom's Cabin; and, as sponsored by the Bias Busters of Kansas and the Kansas Dr. Martin Luther King Jr. Memorial Committee on April 4 at the Topeka-Shawnee County Public Library, the second annual Kansas Inclusion Day: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we recognize the efforts of these civic organizations in maintaining the memory of Dr. Martin Luther King and in furthering his vision of the future of our nation; and

Be it further resolved: That the Secretary of the Senate provide five enrolled copies of this resolution to Angela Waters, 1422 Western, Topeka, Kansas 66604.

On emergency motion of Senator Hensley SR 1847 was adopted unanimously.
