**Senate Bill 547** April 18, 2002

Message to the Senate of the State of Kansas:

As production from the Hugoton gas field declines, a stable supply of natural gas for irrigation wells is becoming a critical challenge to sustaining agriculture production in Southwest Kansas. I am sympathetic to the need for immediate availability of natural gas for customers currently receiving service from production facilities. Therefore, I am signing this bill as a stop- gap measure to provide relief to the agricultural community in Southwest Kansas.

However, I remain convinced that in the long run, public interest is best served by having one distribution system serve an area rather than multiple systems. Once some experience is gained with this act, I would encourage legislators during the 2003 session to investigate the possibilities of developing long range incentives that will provide a fully developed infrastructure capable of delivering a stable supply of gas throughout the affected areas. Only by careful planning by the legislature, private industry and consumers, will we be able to take advantage of the traditional economies of scale that are prevalent throughout our public utility infrastructure.

#### INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Barnett introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1848-

A RESOLUTION congratulating and commending Maisie DeVore.

WHEREAS, Maisie DeVore, 83, of Eskridge has been called "Amazing Maisie" but "Unbelievable Maisie" might be more appropriate. For 30 years she has raised money to build a swimming pool for her town of 530 inhabitants. She collected aluminum cans and scrap metal to sell to recycling plants, sold homemade jam and knitted afghans for raffles. Over the years she has collected more than \$100,000. Her dream has become a reality with a state grant of \$73,000 permitting the town to construct the pool; and

WHEREAS, The local school board donated land for the pool adjacent to the town's elementary school, which location will allow Ms. DeVore to look out of her picture window to watch the activity at the pool. On March 20, 2001, Ms. DeVore broke ground for the pool by turning over the first two spadefuls of dirt--an action which caused her greatgrandson to wonder why his great-grandmother did not dig the entire pool with her golden ceremonial shovel; and

WHEREAS, The pool was finished in time for the 2001 swimming season. Eight hundred people were present for the grand opening on July 14, which was declared Maisie DeVore Day in Eskridge. Following a parade through town, there was a dedication ceremony at the

pool. Ms. DeVore used gold-painted scissors to cut the dedicatory ribbon. Earlier local youth had proposed that Ms. DeVore be given a bikini to wear so she could be the first one in the water. While that did not transpire, she was the first to step into the water; and

WHEREAS, Maisie DeVore's vision of a swimming pool for her home town was supported with 30 years of dedicated effort on her part, a task which was not supported by her neighbors but such lack of support did not deter her from her vision; and

WHEREAS, On March 19, Maisie DeVore was one of five Kansans who received the Jefferson Award, given by the American Institute for Public Service, which honors people who work to improve their communities at local and national levels and has been selected by the American Institute for Public Service to represent northeast Kansas in the national Jefferson Awards ceremony June 17 to 19. She will compete with more than 80 other regional award winners for the Jacqueline Kennedy Onassis Award for Greatest Public Service Benefiting Local Communities. She will receive an all-expense paid trip to Washington, D.C., where the ceremony will be conducted. She also will receive a special invitation to the White House and will attend a ceremony and reception at the United States Supreme Court: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend Maisie DeVore for 30 years of dedicated service to her community, which efforts have enabled Eskridge to have a swimming pool to be enjoyed by today's residents as well as those of tomorrow, and for the example of dedication and perseverance which she has set to be emulated by all citizens of the city of Eskridge and the state of Kansas; and

Be it further resolved: That the Secretary of the Senate provide an enrolled copy of this resolution to Maisie DeVore, P.O. Box 393, Eskridge, Kansas 66423, and Rex Kraus, Mayor, City of Eskridge, 110 S. Main, Eskridge, Kansas 66423.

On emergency motion of Senator Barnett SR 1848 was adopted unanimously.

Senator Barnett and members of the Senate congratulated Maisie with a standing ovation on her many years of continued dedication to a much appreciated community project. Family members accompanying Maisie were Mike Parhomek, Linda Parhomek, Marilyn Allen, Rod Allen, Ladeen Allen, Dayton Allen and Tanner Allen.

The House accedes to the request of the Senate for a conference on **House Substitute for SB 643** and has appointed Representatives Mays, Hutchins and Ruff as conferees on the part of the House.

The House adopts the Conference Committee Report to agree to disagree on **HB 2812** and has appointed Representatives Cox, Humerickhouse and Burroughs as second conferees on the part of the House.

The House adopts the conference committee report on SB 458.

The House adopts the conference committee report on **SCR 1614**.

The House announces the appointment of Representatives O'Neal, Loyd and Pauls to replace Representatives T. Powell, Powers and Alldritt as conferees on **House Substitute** for SB 9

The House did not adopt the conference committee report to agree to disagree on **Senate Substitute for HB 2621** and the bill remains in conference.

#### ORIGINAL MOTION

On motion of Senator Corbin, the Senate acceded to the request of the House for a conference on  ${\bf HB~2586}$ .

The President appointed Senators Corbin, Jenkins and Lee as conferees on the part of the Senate.

On motion of Senator Allen, the Senate acceded to the request of the House for a conference on HB 2878.

The President appointed Senators Allen, O'Connor and Gilstrap as conferees on the part of the Senate.

On motion of Senator Adkins, the Senate acceded to the request of the House for a conference on S Sub for Sub HB 3012.

The President appointed Senators Adkins, Pugh and Hensley as conferees on the part of the Senate.

#### REPORTS OF STANDING COMMITTEES

Committee on Education recommends HB 3003 be passed.

#### COMMITTEE OF THE WHOLE

On motion of Senator Oleen, the Senate resolved itself into Committee of the Whole for consideration of bills on the calendar under the heading of General Orders with Senator Jenkins in the chair.

On motion of Senator Jenkins the following report was adopted:

Recommended  ${\bf HB~2575}$  be amended by adoption of the committee amendments, and the bill be passed as amended.

HB 2020 be amended by adoption of the committee amendments, be further amended by motion of Senator Brungardt as amended by Senate Committee, on page 1, in line 42, preceding the period, by inserting "and shall have a level landing at the top and bottom of each run":

On page 2, in line 3, following the period, by inserting "The accessible route shall be no less than 36 inches wide with a slope not to exceed a ratio of one inch rise to every 20 inch horizontal run."; in line 6, by striking "The threshold of such" and inserting "Beveled edges of the threshold of accessible entrance"; in line 11, by striking "All" and inserting "Except for doors serving closets having less than 15 square feet in area, all"; in line 12, by striking all following "located"; in line 13, by striking all preceding "which"; in line 15, preceding

the period, by inserting "with the door open 90 degrees measured between the face of the door and the doorstop"; in line 16, by striking "within the dwelling"; in line 19, preceding the period, by inserting "with a slope not to exceed a ratio of one inch rise to every 20 inch horizontal run"; in line 22, following the period, by inserting "Beveled edges of such thresholds shall not exceed  $\frac{1}{2}$  inch or, in the case of a sliding door,  $\frac{3}{4}$  inch."; by striking all in lines 23 through 33, following line 33, by inserting:

"(d) In bathrooms located on the same floor on which the accessible entrance is located, the walls at the bathtub, shower and toilet shall be reinforced so that grab bars may be installed at a later date, if needed. Such reinforcement shall be sufficient enough to support a sheer force of 250 pounds.

(e) Light switches, electrical outlets, thermostat controls and other controls located on the same floor on which the accessible entrance is located shall be placed so that a person using a wheelchair can access the controls using either a forward or sideward approach. Such controls shall be placed no less than 15 inches nor more than 48 inches from the floor in the case of a forward approach. Such controls shall be placed no less than nine inches nor more than 54 inches from the floor in the case of a sideward approach. If multiple controls serve the same elements, only one need be accessible.", and HB 2020 be passed as further amended.

On motion of Senator Oleen the Senate adjourned until 10:00 a.m., Thursday, May 2, 2002.
