The Senate was called to order by President Dave Kerr.
The roll was called with forty senators present.
Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

This past week-end we celebrated our state's one hundred and forty-second birthday anniversary. In my prayer today, O God, I want to call our attention to a few little known events which happened first in Kansas.

Most significantly for many of us—the first recorded Christian church service in the future United States took place near present day Dodge City on June 29, 1541. It was conducted by Spanish explorer Coronado's head friar, Rev. Juan de Padilla. This was 320 years before Kansas was admitted to the Union and eighty years before the landing of the Mayflower.

Padilla also established one of the first Christian missions in the United States near Lyons in Rice County. The next year in 1542 Padilla became the first Christian martyr in North America. As You are aware, O God, thousands of Christians have been martyred since then with the twentieth century recording more Christian martyrs than all the other nineteen centuries combined, and today are the most persecuted people group on earth.

So last year marked the 460th anniversary of the martyrdom of the first Christian missionary on our soil.

We pray today for persecuted people groups all over the world and thank You for men and women who pioneered the state we love so much.

SB 68, An act relating to motor vehicles; providing for the helping schools license plate; amending K.S.A. 8-1,141 and repealing the existing section, by Senator Taddiken.

SB 69, An act concerning elections; relating to the date when certain primary elections are held; amending K.S.A. 12-1254, 25-203, 25-1115, 25-2102, 25-2502 and 25-3901 and K.S.A. 2002 Supp. 25-205, 25-302a, 25-1122 and 25-4005 and repealing the existing sections, by Senator Bunten.

SB 70, An act repealing K.S.A. 39-7,154; concerning pass-through of child support, by Committee on Judiciary.

SB 71, An act relating to the Kansas payment center; expiration thereof; amending K.S.A. 2002 Supp. 23-4,118 and repealing the existing section, by Committee on Judiciary.

SB 72, An act relating to the division of vehicles; concerning applications for drivers' licenses and identification cards; amending K.S.A. 8-240, 8-1324 and 8-1417 and repealing the existing sections, by Committee on Judiciary.

SB 73, An act concerning certain claims against the state, making appropriations, authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain disbursements, procedures and acts incidental to the foregoing, by Joint Committee on Special Claims Against the State.

SB 74, An act concerning schools; relating to the powers and duties of the state board of education; relating to personal financial literacy programs, by Senators Schodorf, Adkins, Allen, Barnett, Barone, Brownlee, Brungardt, Buhler, Bunten, Clark, Corbin, Downey, Feleciano, Gilstrap, Gooch, Goodwin, Harrington, Hensley, Jordan, Kerr, Lee, Morris, Oleen, Pugh, Salmans, Schmidt, Steineger, Taddiken, Teichman, Umbarger, Vratil and Wagle.
