INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were introduced and read by title:

SB 250, An act repealing the Kansas performance review act; repealing K.S.A. 75-7101, 75-7102, 75-7103, 75-7104, 75-7105 and 75-7107, by Committee on Ways and Means.

SB 251, An act concerning the state finance council; voting procedures; amending K.S.A. 75-3711 and repealing the existing section, by Committee on Ways and Means.

SB 252, An act transferring the functions of the office of state fire marshal to the board of fire services; amending K.S.A. 31-136, 40-252, 65-506, 75-1506, 75-1510, 75-1515 and 75-1516 and repealing the existing sections, by Committee on Ways and Means.
