SENATE CHAMBER, TOPEKA, KANSAS  
Thursday, March 6, 2003—2:30 p.m.

The Senate was called to order by President Dave Kerr.  
The roll was called with thirty-eight senators present.

Senators Corbin and Schmidt were excused.

President Kerr introduced as guest chaplain, Rev. Greg Durant, Pastor, True Light Baptist Church, Topeka, who delivered the invocation:

## INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were introduced and read by title:

**SB 253**, An act making and concerning appropriations for the fiscal years ending June 30, 2004, and June 30, 2005, for state agencies; authorizing certain transfers, capital improvement projects and fees, imposing certain restrictions and limitations, and directing or authorizing certain receipts, disbursements and acts incidental to the foregoing, by Committee on Ways and Means.

**SB 254**, An act concerning alcoholic beverages; relating to the revocation or suspension of licenses of certain licensees; amending K.S.A. 41-2611 and K.S.A. 2002 Supp. 41-2708 and repealing the existing sections, by Committee on Federal and State Affairs.

**SB 255**, An act concerning taxation; relating to reduction of valuation of real property; amendment of tax rolls; protesting the payment of taxes; amending K.S.A. 2002 Supp. 79-1460 and 79-2005 and repealing the existing sections, by Committee on Ways and Means.

**SB 256**, An act concerning crime victims; relating to compensation for residents involving violent crimes committed outside the United States; amending K.S.A. 74-7301 and repealing the existing section, by Committee on Ways and Means.
