And I have seen very little socializing between blacks and whites at home around the dinner table. They may work together but seldom break bread together. You have told us to love our neighbor, and you did not specify any color or race.

You have made it clear that Godly love is a decision, not a feeling. Help us, O God, to make that decision.

I pray this is the Name of Your only begotten Son, whom You gave because You love us, that we might have everlasting life. (John $3{:}16$)
