EXPLANATION OF VOTE

MR. PRESIDENT: I vote Aye on HB 2109.

The Senate Transportation Committee met today with Col. Seck of the Kansas Highway Patrol, Deb Miller, Secretary of KDOT and the Secretary of KDHE. The subject of the meeting was about the 2004 Highway Fatality and Injury rate.

In 2004, 456 people died in vehicle crashes, over 2000 suffered disabling injuries, and 23,000 suffered other injuries. 76% of all those killed were *not* wearing seat belts. Last year the cost of fatal and injury crashes exceeded 3 billion dollars. Thank each and every one of you that voted for this legislation, you likely saved someone from death or disability.—Les Donovan

MR. PRESIDENT: I regretfully vote No on HB 2109.

If and when the House restores the language in conference which makes 14 and under; not 18 and under as currently eligible for traffic stops and ticketing due to seat belt usage, I will vote, as I have in the past, to increase public safety through increased seat belt usage.

My concern remains as expressed on General Orders yesterday that without an effective Kansas law in place defining and regulating racial profiling as this Senate supported 39-0

on February 23, 2005. Until then stopping someone who "looked 18 or under" is yet another weakening of probable cause.—DAVID HALEY

"AN ACT abolishing Kansas, Inc.; amending K.S.A. 74-5001a, 74-5007a, 74-8102, 74-8111, 74-9303, 74-9306, 75-2935b, 79-1119 and 79-3614 and K.S.A. 2004 Supp. 12-1774, 74-5049, 74-5089, 74-50,134, 74-50,151, 74-8136, 74-8405, 74-99b09, 74-99c07, 74-99c10, 75-2935 and 79-3234 and repealing the existing sections; also repealing K.S.A. 74-50,101, 74-8003, 74-8009, 74-8011, 74-8012, 74-8013, 74-8014, 74-8015, 74-8016, 74-8204, 74- $8310 \ and \ 74-8317 \ and \ K.S.A.\ 2004 \ Supp.\ 74-5095, \ 74-8001, \ 74-8002, \ 74-8004, \ 74-8005, \ 74-8006, \ 74$ 74-8006, 74-8007, 74-8010 and 74-8017."; and the substitute bill be passed.

Committee on Education recommends HB 2252 be amended on page 1, in line 16, by striking "The board of education of any school district may" and inserting "(1) Except as provided by paragraph (3), the board of education of any school district shall"; in line 17, by striking ", if any,"; also in line 17, by striking the comma where it appears for the third time; in line 18, by striking all preceding the period and inserting "at any time the board determines such change is necessary"; in line 19, preceding "member" by inserting "board"; in line 20, by striking all following "olution"; by striking all in lines 21 through 25; in line 26, by striking all preceding the period and inserting ". The board shall draw boundaries of board member districts that are as compact and equal in population as possible. The boundaries of board member districts shall be drawn, to the extent practical, to include whole voting precincts. Upon a finding by the board that whole voting precincts cannot be included, boundaries shall be drawn to include whole census blocks.

(2) If the population of any board member district is at least 5% above or 5% below the mean population of all board member districts within the school district, based upon the most recently published federal decennial census or upon population estimates as determined by the county election officer of the home county of the school district, the board of education of such school district shall change the boundaries of the board member districts so that the population of any board member district is not greater than 5% above nor greater than 5% below the mean population of all board member districts within the school district. If the board does not change the boundaries as required by this paragraph, the county or district attorney of the home county of the school district shall notify the board of its duty to make such changes. If within 60 days after receiving such notification, the board fails to change the boundaries as required by this paragraph, the county or district attorney shall file an action in the district court of such county requesting an order to compel the school board to change the board member district boundaries as required by this paragraph.

(3) No boundary changes shall be made during the ninety-day period preceding any regular election of the school district";

and the substitute bill be passed.

In the title, in line 10, by striking "and K.S.A. 2004 Supp. 41-719 and 41-2645"; and the bill be passed as amended.

Also, **SB 276** be amended on page 2, in line 43, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

Committee on Financial Institutions and Insurance recommends SB 269; HB 2125, as amended by House Committee of the Whole; HB 2160, as amended by House Committee; HB 2205 be passed.

Also, **HB 2326**, as amended by House Committee, be amended on page 6, in line 17, by striking all following "claims" and inserting "which have not been paid prior to the effective date of this act.";

On page 8, in line 10, by striking all following "claims"; in line 11, by striking all preceding the period and inserting "which have not been paid prior to the effective date of this act"; in line 15, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

Committee on **Judiciary** recommends **HB 2180** be passed.

HB 2386, as amended by House Committee, be amended on page 2, in line 36, by striking "direct"; in line 37, by striking "the offender" and inserting "court services and the offender has knowledge that the person with whom the offender is engaging in consensual sexual intercourse, lewd fondling or touching, or sodomy is currently under the supervision of court services";

On page 3, in line 1, by striking "direct"; also in line 1, by striking "the offender" and inserting "community corrections and the offender has knowledge that the person with whom the offender is engaging in consensual sexual intercourse, lewd fondling or touching, or sodomy is currently under supervision of community corrections"; in line 22, before the period by inserting ";

- (10) "community corrections" means the entity responsible for supervising adults and juveniles for confinement, detention, care or treatment, subject to conditions imposed by the court pursuant to the community corrections act, K.S.A. 75-5290, and amendments thereto:
- (11) "court services" means the entity appointed by the district court that is responsible for supervising adults and juveniles placed on probation and misdemeanants placed on parole by district courts of this state; and
- (12) 'Îaw enforcement officer' means the same as prescribed by K.S.A. 21-3110, and amendments thereto'; and the bill be passed as amended.

Committee on **Public Health and Welfare** recommends **HB 2077** be amended on page 1, in line 23, after the semicolon, by inserting "or"; in line 24, by striking the semicolon; by striking all in lines 25 and 26; in line 27, by striking all before the period; in line 32, by striking all after "(B)";

And by relettering paragraphs accordingly;

Also on page 1, in line 33, by striking all before the semicolon and inserting: "a mid-level practitioner as defined in K.S.A. 65-1626 and amendments thereto"; in line 34, by striking "and dental hygienists":

On page 2, by striking all in line 8; in line 9, by striking all before "and"; in line 10, by striking "(D)" and inserting "(C)"; preceding line 11, by inserting the following:

"(8) "Person" means any individual, corporation, government, governmental subdivision or agency, partnership, association or any other legal entity.";

Also on page 2, in line 24, by striking all after the period; by striking all in lines 25 and 26; in line 27, by striking all after "person"; in line 28, by striking all before "may";

On page 3, in line 5, by striking all after "(a)"; by striking all in lines 6 through 23 and inserting: "Any person who in good faith donates cancer drugs without charge to the cancer drug repository program which drugs are in compliance with the provisions of this act at the time donated shall not be subject to criminal or civil liability arising from any injury or death due to the condition of such drugs unless such injury or death is a direct result of the willful, wanton, malicious or intentional misconduct of such person.

(b) Any person who in good faith dispenses cancer drugs without charge, except as provided in this act, in accordance with the provisions of this act and as part of the cancer drug repository program which drugs are in compliance with the provisions of this act at the time dispensed shall not be subject to criminal or civil liability arising from any injury or death due to the condition of such drugs unless such injury or death is a direct result of the willful, wanton, malicious or intentional misconduct of such person."; and the bill be passed as amended

Committee on **Utilities** recommends **HB 2461**, as amended by House Committee, be passed.

Committee on **Ways and Means** recommends **HB 2364**, as amended by House Committee, be passed.

SB 243 be amended by adoption of the committee amendments, be further amended by motion of Senator Umbarger as amended by Senate Committee, on page 2, in line 35, before the semicolon by inserting "as determined by the secretary"; in line 37, by striking "Amer-"; in line 38, by striking all before the semicolon and inserting "secretary";

On page 3, in line 1, by striking all after "insurance"; in line 2, by striking all before the semicolon and inserting ", the amount to be determined by the secretary"; in line 22, by striking all after "facility"; in line 23, by striking all before the semicolon;

On page 4, in line 12, by striking all after "act"; in line 13, by striking all before the period; in line 25, after "review" by inserting "and approve or reject";

On page 7, in line 20, before the period by inserting ", and the secretary, as to the determination of the best interests of the state of Kansas";

On page 8, in line 2, after "fees" by inserting ", monitoring fees, and any other fees authorized by this act"; in line 7, by striking all after "of"; by striking all in line 8; in line 9, by striking all before the period and inserting "the costs associated with the implementation and enforcement of this act.
