REPORTS OF STANDING COMMITTEES

The Committee on **Utilities** recommends **HB 2590** be amended on page 1, after line 25, by inserting the following:

"(b) "Interconnected VoIP service" has the meaning provided in 47 C.F.R. 9.3 (October 1, 2005)."

And by relettering the remaining subsections accordingly.

Also on page 1, in line 41, by striking "VoIP service" and inserting "interconnected VoIP service but does not include any telecommunications carrier or local exchange carrier, as defined in K.S.A. 66-1,187, and amendments thereto, which holds a certificate of public convenience and necessity issued by the state corporation commission"; in line 42, by striking all after "means"; in line 43, by striking "service" and inserting "a subscriber to interconnected VoIP service whose primary service address is in Kansas":

nected VoIP service whose primary service address is in Kansas";
On page 2, in line 6, by striking "sub-"; in line 7, by striking all before the period and inserting "service user"; in line 19, by striking "subscriber whose primary residence is in the state of Kansas" and inserting "service user";

On page 4, in line 35, by striking all after "for"; in line 36, by striking "nary care" and inserting "gross negligence"; in line 40, after the period by inserting "In addition, a VoIP provider, and its officers, directors, employees, vendors and agents, shall have the same immunity and other protection from liability in this state as that provided to wireless carriers under 47 U.S.C. 615a (October 26, 1999).":

On page 7, in line 12, by striking "2006" and inserting "2007"; in line 15, by striking "2006" and inserting "2007"; in line 24, by striking "2006" and inserting "2007";

On page 8, in line 16, by striking "2006" and inserting "2007"; in line 19, by striking "2006" and inserting "2007"; in line 37, by striking "2006" and inserting "2007"; and the bill be passed as amended.
