#### HOUSE CONCURRENT RESOLUTION No. 5031-

By Committee on Health and Human Services

A CONCURRENT RESOLUTION urging providers of health insurance to encourage certain insured individuals to have an up-to-date living will and advanced directives.

WHEREAS, The cost of health care continues to increase faster than the cost of living; and

WHEREAS, Under Kansas law a Kansas citizen may execute a document termed a durable power of attorney for health care decisions, commonly referred to as advanced directives, wherein the individual may direct the withholding or withdrawal of life-sustaining procedures in a terminal condition; and

WHEREAS, Under Kansas law, a Kansas citizen may execute a document termed a declaration, commonly referred to as a living will, authorizing another individual to act for an ill person upon the ill person's subsequent disability or incapacity; and

WHEREAS, Unless a person has a living will or advanced directives, such person when hospitalized for a life-threatening condition may be subject to being treated with life-saving measures against the person's will and desire; and

WHEREAS, The unnecessary use of life saving measures increases the costs of health care for all citizens of the state of Kansas: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Legislature strongly urges the insurance industry to consider providing rate reductions or other incentives for policyholders or applicants for health insurance, particularly any person who is at least 40 years of age, to have a current living will and durable power of attorney for health care decisions; and

Be it further resolved: That the Secretary of State provide an enrolled copy of this resolution to the Commissioner of Insurance who is hereby directed to send a copy of this resolution to each insurance company which sells health insurance in this state.
