**HB 2762**, An act concerning adult care home administrators; amending K.S.A. 2005 Supp. 65-3506 and 65-3508 and repealing the existing sections, by Committee on Appropriations.

**HB 2763**, An act concerning agriculture; relating to livestock; premises registration and animal identification and tracking system; amending K.S.A. 2005 Supp. 47-674 and repealing the existing section, by Committee on Agriculture.

**HB 2764**, An act concerning elections; relating to campaign finance, by Committee on Governmental Organization and Elections.

**HB 2765.** An act concerning school finance; relating to at-risk pupils; amending K.S.A. 2005 Supp. 72-6407 and repealing the existing section, by Committee on Education.

**HB 2766.** An act concerning retirement and pensions; relating to the Kansas public employees retirement system and systems thereunder; postretirement benefit adjustment; amending K.S.A. 2005 Supp. 74-4920 and repealing the existing section, by Representative S. Sharp (By request).

**HB 2767.** An act concerning taxation; relating to the board of tax appeals; membership; amending K.S.A. 2005 Supp. 74-2433 and repealing the existing section, by Committee on Taxation.

**HB 2768.** An act concerning income taxation; relating to capital gains; amending K.S.A. 79-32,138 and K.S.A. 2005 Supp. 79-32,117 and repealing the existing sections, by Committee on Taxation.
