SB 433, An act relating to oil and gas research; establishing the KUERC oil and gas research fund; providing for the funding thereof; amending K.S.A. 2005 Supp. 79-4227 and repealing the existing section, by Committee on Utilities (By request of Select Joint Committee on Energy).

SB 434, An act concerning corrections; relating to community supervision; amending K.S.A. 2005 Supp. 75-5291 and repealing the existing section, by Committee on Judiciary.

SB 435, An act concerning sentencing; relating to presentence investigation reports; amending K.S.A. 2005 Supp. 21-4714 and repealing the existing section, by Committee on Judiciary.

SB 436, An act concerning school districts and community colleges; relating to personnel evaluations; amending K.S.A. 72-9002 and K.S.A. 2005 Supp. 72-9003 and repealing the existing sections, by Senator Vratil.

SB 437, An act concerning insurance; relating to subrogation and reimbursement rights under health insurance policies, by Senator Journey.

SB 438, An act concerning personal property taxation; relating to motor vehicles; computation of amount of tax; amending K.S.A. 79-5105 and repealing the existing section, by Committee on Assessment and Taxation.
