PRESENTATION OF PETITIONS

The following petitions were presented, read and filed:

SP 2, by Senator Stephen Morris: A petition in support of **SB 408**, declaring animal cruelty a felony, submitted by Glenda Hopkins, Garden City and surrounding cities, and 605 other constituents across the state of Kansas.

SP 3, by Senator Tim Huelskamp: A petition to declare our support for a Constitutional Amendment declaring that the Judiciary has no authority to dictate how Elected Representatives of the People should raise and spend hard-earned money, submitted by James and Ramona Floyd, Liberal, Kansas and 249 other constituents across the state of Kansas.

INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were introduced and read by title:

SB 506, An act concerning persons required to register pursuant to the Kansas offender registration act; providing for an annual driver's license or identification card; residency restrictions; juvenile offenders required to register; sexually violent predators; amending K.S.A. 59-29a02, 59-29a07 and 59-29a11 and K.S.A. 2005 Supp. 8-243, 8-247, 22-4904, 22-4905 and 22-4906 and repealing the existing sections, by Committee on Judiciary.

SB 507, An act concerning court costs; relating to a fee upon request for jury; amending K.S.A. 60-2001 and repealing the existing section, by Committee on Judiciary.

SB 508, An act concerning schools; relating to human sexuality education programs; establishing the abstinence plus education act, by Committee on Education.

SB 509, An act concerning school finance; relating to at-risk pupils; amending K.S.A. 72-6419 and 72-6447 and K.S.A. 2005 Supp. 72-978, 72-6407, 72-6409 and 72-6414a and repealing the existing sections; also repealing K.S.A. 2005 Supp. 72-6414, by Committee on Education.

SB 510, An act relating to roads and highways; concerning the classification thereof; amending K.S.A. 2005 Supp. 68-101 and 68-402b and repealing the existing sections, by Committee on Transportation.

SB 511, An act concerning health clubs; requiring the availability of an automated external defibrillator and the availability during business hours of a qualified person to operate such defibrillator, by Committee on Public Health and Welfare.
