SENATE CHAMBER, TOPEKA, KANSAS Friday, February 24, 2006—9:30 a.m.

# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Emler introduced the following Senate resolution, which was read:

#### SENATE RESOLUTION No. 1816

A RESOLUTION congratulating and commending the Hospira manufacturing facility at McPherson.

WHEREAS, Hospira, Inc., a global specialty pharmaceutical and medication delivery company, recently announced an expansion of its McPherson facility. The \$50 million expansion will provide additional capacity for new Hospira drugs, accommodate growth of One 2 One, the company's pharmaceutical outsourcing business and increase production of its pharmaceutical injectables. Approximately 150,000 square feet of floor space will be created for office, laboratory and manufacturing use and will result in the creation of up to 172 additional well-paying jobs for the McPherson community; and

WHEREAS, The company's expansion is assisted in part by the Kansas Bioscience Authority's dedication of \$200,000 for a three-year program of financial aid to graduates of Kansas colleges and universities who will intern at Hospira; and

WHEREAS, The McPherson Hospira plant was established in 1977 on 160 acres originally owned and operated by Sterling Drug Company. It is the largest employer in McPherson and currently employs approximately 850 scientists, technicians and production workers. The plant makes various products used in health care institutions for pain management, respiratory care and cardiovascular care; and

WHEREAS, Hospira was created from the hospital products business of Abbott Laboratories in 2004. Although a new company, it has a history of 70 years providing products to the hospital industry. The company produces one of the industry's broadest range of generic acute-care injectables and is the leading American injectable manufacturing business: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend the Hospira company upon the expansion of its manufacturing facility at McPherson and wish it great success as it continues with supplying essential products for modern medical

On emergency motion of Senator Emler SR 1816 was adopted unanimously. Senator Emler introduced the following Senate resolution, which was read:

# SENATE RESOLUTION No. 1817

A RESOLUTION congratulating and commending the Willing Workers Society.

WHEREAS, The Willing Workers Society of Ellsworth County is celebrating its 100th anniversary. The society was organized by ladies from the Ash Creek and Thomas Townships in Ellsworth County in February 1906 and met on the third Thursday of every month. While the averred purpose of the organization was charity, a large part of the success of the organization was the social part of the meetings and the friendships that were generated from these meetings. Children were a part of the meetings, and even a few men could be found in attendance; and

WHEREAS, As established by its early by-laws, membership was limited to 15 and dues were 10 cents a month. Membership was later expanded to 25 and dues to three dollars a year. A member was declared an honorary member after being in the organization 25 years and absolved of the duty of entertaining, but this provision had to be discontinued as eventually there were not enough regular members to act as hostesses for their meetings; and

WHEREAS, For many years the two hostesses for the month would prepare baked goods, jellies or crafts and handiwork which would be auctioned off at the end of the monthly meeting. This activity provided a basis for their charitable deeds. Originally, they sponsored a shower and dance for members' children upon their marriage. As times changed, they sponsored a card party and shower, and the current practice is to give a monetary gift to the newlyweds. Another appreciated practice of the society was to provide food for funeral dinners as well as providing care and support for the bereaved; and

WHEREAS, In 1981 the society published its first cookbook, "Our Favorite Recipes" which soon was sold out as well as two reprints. In February it printed another cookbook, "Favorite Recipes". The society maintained its own building, the Community House, until 1984 when it was sold at auction with many society members purchasing mementos from the building; and

WHEREAS, There have been 90 members in this society, an organization which remains proud and alive on its 100th anniversary. It continues its charitable activity by sponsoring two \$300 college scholarships each year: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend the Willing Workers Society upon its 100th anniversary and hope that the society can continue and prosper in the future; and

Be it further resolved: That the Secretary of the Senate provide an enrolled copy of this resolution to Mrs. Ona Wright, 1096 Avenue M, Ellsworth, KS 67439 and a copy to Senator Emler.

On emergency motion of Senator Emler SR 1817 was adopted unanimously.

Senator Brownlee further amended **SB 506**, as amended by Senate Committee, on page 20, after line 27, by inserting the following:

"(G) The sex offender policy board established pursuant to subsection (e)(8) of this section shall expire on June 30, 2008.", and  ${\bf SB~506}$  be passed as further amended.

The Committee rose and reported progress (see Committee of the Whole, afternoon session).

# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Betts introduced the following Senate resolution, which was read:

## SENATE RESOLUTION No. 1818

A RESOLUTION encouraging school districts to consider school uniforms or dress codes.

WHEREAS, Our children are our most precious asset; and

WHEREAS, Children's school experiences are too often disrupted by disputes between children about the clothing they are wearing; and

WHEREAS, Children too often draw distinctions between themselves and others based on the clothing they wear, leading to social stratification in a time of life that children should be focusing on developing the skills necessary to succeed in life; and

WHEREAS, Many gangs use the wearing of certain colors or types of clothing as a badge of membership, leading to even more disputes between children about the clothing they are wearing; and WHEREAS, It has been shown that school uniforms generally cost less than the clothes worn in schools where there is no school uniform; and

WHEREAS, Studies show that elementary and secondary schools with a policy concerning school uniforms or exacting dress codes and a policy of zero tolerance for infractions of the code have fewer disciplinary problems, score higher on many standardized tests and learn better manners; and

WHEREAS, Current styles of clothing are often too sexually suggestive or glorify images of violence and law-breaking, exposing children to issues they are not intellectually or emotionally ready to process; and

WHEREAS, Students who must abide by a strict dress code or student uniform learn how to choose clothing that is appropriate to the workplace and are thus prepared to accept the dress code of the company where they eventually will be employed: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That school districts throughout Kansas study the record of results from other schools and school districts that have instituted strict dress codes, especially those that have instituted school uniforms, with the purpose of determining whether a strict dress code or school uniform policy would be of benefit to Kansas students.

# EXPLANATION OF VOTE

MR. PRESIDENT: I vote NO on SB 508 and would like to explain my vote.

For years, human sexuality has been taught to the children of Kansas by parents and teachers. The decision has rested in parents first and local school boards, second.

Education about abstinence, AIDS and sexually transmitted infection is needed and appropriate, but I believe the decision should remain at the level of the home first and the locally elected school board, last.
