## THIRTY-NINTH DAY

Senate Chamber, Topeka, Kansas Monday, March 6, 2006—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-seven senators present. Senators Barnett, Haley and Wagle were excused. Invocation by Chaplain Fred S. Hollomon:

The following bills were introduced and read by title:

SB 584, An act concerning school districts; relating to school finance; amending K.S.A. 72-6441 and K.S.A. 2005 Supp. 72-978, 72-6407, 72-6410, 72-6412, 72-6414, 72-6415b, 72-6433, 72-6434 and 72-6442b and repealing the existing sections, by Committee on Ways and Means

SB 585, An act concerning sales taxation; relating to exemptions; TLC for children and families, inc.; amending K.S.A. 2005 Supp. 79-3606 and repealing the existing section, by Committee on Ways and Means.

SB 586, An act relating to higher education; relating to building and facility maintenance; revenue raised pursuant to certain specified tax authority; amending K.S.A. 76-6b02 and K.S.A. 2005 Supp. 76-6b01, 79-3603, 79-3620, 79-3703 and 79-3710 and repealing the existing sections, by Committee on Ways and Means.

## REPORTS OF STANDING COMMITTEES

Committee on **Commerce** recommends **SB 382** be amended on page 1, in line 15, after "Sec. 2." by inserting "(a)"; in line 16, by striking "administrative"; in line 20, by striking "(a)" and inserting "(1)"; in line 21, by striking "(b)" and inserting "(2)"; in line 22, by striking "(c)" and inserting "(3)"; also in line 22, after the semicolon by inserting "and"; by striking all in line 23; in line 24, by striking "(e)" and inserting "(4)"; after line 24, by inserting the following:

"(b) The secretary shall provide technical assistance to grantees, evaluate programs for effectiveness and act as a data repository to coordinate funding and ensure that state funds are not directed toward program duplication. The secretary may enter into agreements to carry out the provisions of this subsection.";

Also on page 1, in line 25, by striking ", "eligible entity" and inserting ":

(a) "After-school program" means a program which requires meeting for a minimum duration of: (1) Two hours per day during each day school is in session; or (2) six hours per day each weekday for at least five consecutive weeks outside of the school year.

(b) "Eligible entity" ";

Also on page 1, in line 29, by striking "(a)" and inserting "(1)"; in line 31, by striking "(b)" and inserting "(2)"; in line 32, by striking "(c)" and inserting "(3)";

On page 2, in line 8, after "and" by inserting ": (1) The individual"; also in line 8, before

the period by inserting "; or

(2) the individual is enrolled in grade 5, if such grade level is part of a middle school or junior high school"; in line 23, by striking all after "include"; by striking all in lines 24 and 25; in line 26, by striking all before "an" and inserting "an evaluation of pre-vocational skills and options offered and acquired, physical fitness improvement, academic improvement and mentoring participation, as well as"; and the bill be passed as amended.

Committee on Judiciary recommends HB 2562, HB 2606, HB 2607, HB 2617, HB

**2626**, **HB 2665**, **HB 2704** be passed.

Also, **HB 2610**, as amended by House Committee, be amended on page 3, in line 19, by striking the first "and" and inserting a comma; also in line 19, after "40-218" by inserting "and 50-631"; and the bill be passed as amended.

Committee on **Ways and Means** recommends **HB 2574** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

On motion of Senator D. Schmidt the Senate adjourned until  $2:30~\mathrm{p.m.}$ , Tuesday, March 7,2006.
