## MOTIONS AND RESOLUTIONS OFFERED ON A PREVIOUS DAY

On motion of Rep. Goico, **HCR 5007**, A concurrent resolution supporting Wichita State University for full reaccreditation by the Higher Learning Commission of the North Central Association of Colleges and Schools, was adopted.

There being no objection, the following remarks of Rep. Goico are spread upon the journal.

Wichita State University was founded in 1895 as Fairmount College, a Congregational institution. Its distinguishing characteristics are its urban setting and the enhancement that it provides to the traditional classroom experience through greater opportunities in resources, contacts with business and government leaders, employment, and internships. WSU became a state institution in 1963 and since that time it has grown from 5,000 to over 14,000 students. These students are primarily from South Central Kansas and in most cases remain and work in Kansas following graduation.

The university is continuously evaluating its programs and seeking opportunities to increase and expand its efforts on behalf of the citizens of Kansas. WSU has continued to build strong university-community partnerships in aeronautical engineering, community health and safety, continuing and cooperative education, arts and culture, as well as in economic development. This has been accomplished through the "WSU-LINK" program.

WSU is also noted for its high levels of service learning, and community based participatory research. The National Institute of Aviation Research (NIAR) has three FAA Centers of Excellence, 192 industry clients and three contributing partners: the FAA, NASA, and the Kansas Technology Enterprise Organization. Over the past 10 years the university has achieved over 200 percent growth on basic and applied research funding. This is mainly the result of the efforts of the university to serve the needs of the Kansas aviation industry. Students also receive a large number of opportunities to connect academic experiences with a wide range of co-operative education and internship experiences. In fact, Wichita State University has the largest internship and co-operative education program in the state. This is a direct result of the linkage the university has with its community. In areas such as the Hugo Wall School of Urban and Public Affairs, the health professions, and the Barton School of Business; it has expanded to include the entire state. And, via distance and global learning, a much broader range of constituencies is further served.
