On page 4, in line 15, preceding "qualified" by inserting "(based on climate zone as defined in the most current Energy Star Qualified Homes National Performance Path Requirements)"; in line 17, following the period, by inserting "Energy Star Performance Requirements: To qualify as Energy Star, a home must meet the minimum requirements specified, be verified and field-tested in accordance with the RESNET standards by a RESNET-accredited Provider, and meet all applicable codes."; and HB 2036 be passed as amended.
