Hall of the House of Representatives, Topeka, KS, Wednesday, February 7, 2007, 11:00 a.m.

Dear Speaker Neufeld:

Thank you for your efforts and for those of the Select Committee on Contested Election to resolve the issues clouding the election result in District 16.

It is an unfortunate set of circumstances that led this matter to be before the Kansas House of Representatives in the first place. Circumstances which, with greater diligence at the county level, could have been avoided. Instead, the legitimacy of the election of either

party to this contest will remain forever in question and, regrettably, a cloud of doubt will forever hang over the result.

I appreciate the Select Committee's examination of the issues raised. Both the Committee and the District Court found illegal ballots were cast in the District 16 race, as well as a failure to follow statutory procedures by the Johnson County Election Commissioner and Board of Canvassers. Such deviations from statue impaired both the evidence available to the Committee and any determination with certainty of the true outcome of the election. However, the Committee has, after exercising its best efforts with the evidence available to it, reached its conclusion. I respect the Committee process.

I have been told that, despite the conclusion of the committee, I might prevail in this contest if it were brought to the House floor. However, I believe that such an exercise, regardless of outcome, in today's political climate, would likely impede the thoughtful deliberation of other important matters before this body. Rather, this matter should be used as a case study for the House to consider needed reforms to State election laws, and to emphasize to appointed and elected officials presiding over the election and canvassing processes the importance of diligence and adherence to Kansas law in the execution of their respective duties.

Therefore, in the best interest of all Kansans, I hereby withdraw my contest of this election, and I hereby congratulate Representative Rardin on his appointment to the House.

#### COMMITTEE OF THE WHOLE

On motion of Rep. Grange, Committee of the Whole report, as follows, was adopted: Recommended that **HCR 5009** be adopted.

Committee report to **HB 2073** be adopted; also, on motion of Rep. Burroughs be amended on page 2, after line 3, by inserting the following:

"Sec. 2. K.S.A. 20-3127 is hereby amended to read as follows: 20-3127. (a) Except as provided further, all fees collected pursuant to K.S.A. 20-3126, and amendments thereto, shall be used to establish and maintain the county law library. A board of trustees, appointed as provided in this section, shall have the management and control of such library and shall use the fees paid for registration, and all other sums, books, or library materials or equipment donated or provided by law, for the purpose of establishing and maintaining such library in the county courthouse or other suitable place to be provided and maintained by the county commissioners of such county. The district judge or district judges of the district court, members of the bar who have registered and paid the fee provided for in K.S.A. 20-3126, and amendments thereto, judges of all other courts in the county and county officials shall have the right to use the library in accordance with the rules and regulations established by the board of trustees. The board of trustees shall develop guidelines to provide members of the public reasonable access to the law library.

(b) The board of trustees of any law library established or governed under this act, and amendments thereto, in Johnson and Sedgwick counties shall consist of five members, two of which shall be judges of the district court, appointed by a consensus of all judges of the district court in those counties, and three of which shall be members of the Johnson or Sedgwick county bar association, appointed by selection of the county bar association pursuant to the Johnson or Sedgwick county bar association's bylaws for two-year terms. The board of trustees of the law library in all other counties shall consist of the district judge or judges of the district court presiding in such county and not less than two attorneys who shall be elected for two-year terms by a majority of the attorneys residing in the county.

(c) The clerk of the district court of the county shall be treasurer of the library and shall safely keep the funds of such library and disburse them as the trustees shall direct. The clerk shall be liable on an official bond for any failure, refusal or neglect in performing such duties.

(d) The board of county commissioners of any county designated an urban area pursuant to K.S.A. 19-2654, and amendments thereto, wherein an election has been held to come under the provisions of this act is hereby authorized to appoint, by and with the advice and consent of the board of trustees of the law library of such county, a librarian, who shall act as custodian of the law library of such county and shall assist in the performance of the clerk's duties as treasurer thereof, and such assistants as are necessary to perform the duties of administering the law library. The librarian and any assistants so appointed shall be employees of the county under the supervision of the board of county commissioners, or the board's designated official, with the advice and recommendations of the board of trustees of the law library, and shall be subject to the personnel policies and procedures established by the board of county commissioners for all employees of the county. The librarian and any assistants shall receive as compensation such salaries and benefits as established by the law library board of trustees, subject to the approval of the board of county commissioners, which shall be payable from the general fund of the county, through the county payroll process, from funds budgeted and made available by the law library board of trustees for that purpose through the collection of fees or other funds authorized by this act.

(e) All attorneys registered under this act shall not be liable to pay any occupational tax or city license fees levied under the laws of this state by any municipality.

(f) The board of trustees of the law library in Wyandotte county may expend any fees collected for the benefit of the law library to advance and improve the existing technology in the law library and the courtrooms in Wyandotte county.";
