## INTRODUCTION OF ORIGINAL MOTIONS AND HOUSE RESOLUTIONS

The following resolution was introduced and read by title:

## HOUSE RESOLUTION No. 6009-

By Committee on Insurance and Financial Institutions

A RESOLUTION calling on the state bank commissioner to educate Kansas state chartered banks under the jurisdiction of the commissioner about the use of health savings accounts.

WHEREAS, The number of uninsured Kansans has risen substantially since the year 2000, especially among the self-employed and small businesses. A continued decline in the number of Kansans with employer-provided health insurance along with a weakening of the health insurance safety net will undoubtedly cause more Kansans to lose health insurance coverage and therefore access to adequate health care. Recent research indicates that children without health insurance have higher health care costs than children with health insurance; and

WHEREAS, Health savings accounts, made available by state chartered banks, are one alternative available to cover health costs while offering tremendous tax advantages. Health savings accounts (HSA's) were created by the Medicare bill signed by President Bush on December 8, 2003, and are designed to help individuals save for future qualified medical and retiree health expenses on a tax-free basis. Combined with high deductible health insurance policies, HSA's may provide an affordable health insurance alternative to small businesses currently unable to provide health insurance to their employees. An HSA is an asset of the insured which encourages wise use of health care services; and

WHEREAS, Providing health care insurance prevents catastrophic losses which could put otherwise uninsured Kansans into poverty and bankruptcy. Furthermore, HSA contributions are tax deductible, money in the HSA accrues tax-free, money can be withdrawn any time for expenses not covered by health insurance, excess funds may be rolled over into a traditional IRA and expenses for the entire family can be paid for even if they are not on the HSA account holder's health insurance: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we request the state bank commissioner to educate Kansas state chartered banks under the jurisdiction of the commissioner about the use of health savings accounts. That the state bank commissioner encourage state banks to provide health savings accounts to their customers and educate banks on how to set up and administer health savings accounts; and

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to the President of the Senate and the State Bank Commissioner.

#### EXPLANATIONS OF VOTE

Mr. Speaker: We support **HB 2031** as amended. Kansas businesses pay a tax on their assets, even if they are not profitable. This tax is a penalty for making business investments. Eliminating this tax will make Kansas more competitive and economically strong.

While we whole-heartedly support health care for working Kansans, the Homestead Act, and debt-reduction; a tax bill is no place for these debates. We should not try a "quick-fix" to these issues by amending them onto a tax measure.

Also on page 2, in line 19, by striking all following "5."; by striking all in lines 20 through 22 and inserting "Nothing in this act shall diminish or expand any existing rights under the laws of Kansas or the United States relative to services or materials provided by the government of Kansas in any language other than English.

Sec. 6. The state of Kansas recognizes the importance of establishing and actively promoting English language classes, training or other educational services for non-native speakers. The local entity designated by the Kansas state department of education to offer such services shall seek the assistance of local political subdivisions, community-based agencies and organizations, migrant worker groups, refugee resettlement programs, schools, churches and others in making non-native speakers aware of the availability of such services and ensuring their continuation and expansion.";

And by renumbering the remaining sections accordingly; and the bill be passed as amended.

Committee on **Veterans, Military and Homeland Security** recommends **HB 2209** be amended on page 2, in line 17, following "fees" by inserting "for up to 10 semesters of undergraduate instruction, or the equivalent thereof, at all such institutions"; in line 22, following "service" by inserting "in Iraq or Afghanistan"; also in line 22, by striking "who" and inserting ": (A) Who"; in line 23, following "Kansas" by inserting "or who as a resident of Kansas has received a general educational development (G.E.D.) credential; and (B)"; in line 24, preceding the period by inserting "or served less than such 90-days because of nijuries received in Iraq or Afghanistan"; also in line 24, by striking "Any"; by striking all in lines 25 through 29; in line 30, by striking "Subject to appropriations therefor, any" and inserting "Any"; in line 31, by striking ", of a prisoner"; in line 32, by striking all preceding "is"; in line 34, preceding the period by inserting ", less any amounts received from federal military tuition assistance"; also in line 34, by striking all following the period; by striking all in lines 35 and 36; in line 43, by striking all following "eligible";

On page 3, in line 1, by striking all preceding "are" and inserting "persons"; in line 4, by striking all following "such"; in line 5, by striking all preceding "are" and inserting "persons"; also in line 5, by striking all following "eligible"; in line 6, by striking all preceding "discontinues" and inserting "person"; in line 9, by striking "dependent or spouse or prisoner of war" and inserting "person"; in line 11, by striking all following "such"; in line 12, by striking all preceding "for" and inserting "person"; in line 14, following the period by inserting "There is hereby created in the state treasury the tuition waiver fund to be administered by the state board. Upon certification to the director of accounts and reports by the chief executive officer of the state board, or such officer's designee, of amounts needed to pay claims pursuant to this section, the director of accounts and reports shall transfer the amount certified from the state general fund to the tuition waiver fund."; in line 17, by striking all

following "persons"; in line 18, by striking all preceding "and"; and the bill be passed as amended.

Committee on **Veterans, Military and Homeland Security** recommends **HB 2425** be amended on page 2, in line 33, by striking ", (2)" and inserting "; and (2)"; in line 26, by striking the semicolon; in line 37, by striking all preceding the period;

On page 3, in line 12, following "means" by inserting ": (A)"; in line 13, by striking all following "States"; in line 14, by striking all preceding the period and inserting "; or (B) membership in the Kansas army or air national guard"; and the bill be passed as amended.
