EXPLANATIONS OF VOTE

MR. SPEAKER: I vote NO on **HB 2530**. What are we thinking? Every single Kansan loses under **HB 2530**. By passing this bill, we are protecting the members of the billion dollar health care industry at the expense of Kansas health care consumers. **HB 2530** is the worst kind of special interest legislation. We should protect Kansas patients instead of trying to justify a special exception to our consumer protection laws. I vote NO.—MARTI CROW

Mr. Speaker: I vote NO on **HB 2530**. The Kansas Consumer Protection Act was intended to protect Kansans from swindles, cons, and rip-offs. There is no valid reason for the health care industry to be held to a lower standard of consumer protection than nearly every other business and profession.

We say we want to improve access to health care, regulate abortion clinics, and protect frail seniors. Yet **HB 2530** does nothing to improve health care quality for Kansas citizens. Instead, it protects the worst of the worst-health care charlatans that intentionally deceive patients for profit. I vote NO.—DALE SWENSON

MR. SPEAKER: I vote NO on **HB 2530**. I oppose any change to the Kansas Consumer Protection Act that would exempt physicians, lawyers, or any other profession or business from Act's protections for the same reason I oppose any proposal to exempt any class from traffic laws, liquor laws, illicit drug laws or ciminal laws. If we proclaim that we are *all* equal before the law, then we must act like we are *all* equal under the law. I vote NO.—Annie Kuether, Julie Menghini

MR. Speaker: We vote YES on **HB 2530**. This is a carefully limited exception to the consumer protection act. It does not shield physicians from being held accountable for their actions, nor does it prevent a patient from bringing a consumer protection act claim against a physician or health care provider for deceptive business practices. The bill just makes it clear that negligence and standard of care claims are addressed through the medical malpractice tort system, and deceptive billing, advertising, or business disputes are addressed through the consumer protection act. Without this clarification, there would be increased litigation, defense costs, malpractice insurance costs, and ultimately, increased health care costs for Kansans.—MICHAEL R. Notice of such action shall be given to the owner or owners, or their agent or agents, if residing in the county, or, if such owner is incapacitated, to the guardian of such person, if a resident of the county, through whose inclosed or cultivated lands such road is laid out or established. Such notice shall direct such property owners to open such road through their lands within 90 days after service of such notice. If the person or persons so notified do not open such road within the time stated in such notice, it shall be lawful and it is hereby made the duty of such county engineer on state and county roads and of such trustee on township roads and mail route roads to respectively enter upon such property and open such roads. If such notice is given between the March 1, and October 1, the notice shall designate the next following January 1, as the time of opening such road. And the county engineer or township trustee respectively shall keep the same in repair, and remove or cause to be removed all obstructions that may be found therein. The township trustee and the county engineer are hereby authorized to enter upon any land near or adjoining such public road, to dig and carry away any gravel, sand, stone, clay, gypsum or any other road-building material and to purchase any timber which may be necessary to improve or repair the road, and to enter upon any land adjoining or lying near such road, to make such drains or ditches through the same as the county engineer or township trustee deems necessary for the benefit of the roads, doing as little damage to the lands as the nature of the case and the public good will permit. The drains and ditches thus made shall be kept open if necessary by the township trustee or county engineer and shall not be obstructed by the owner or occupants of the land or by any other person, under the penalty of being fined not exceeding \$10 for

The owner of any gravel, sand, stone, clay, gypsum or any other road-building material taken, or the owner of the land through which ditches or drains may be made, as herein provided, or the owner of the crops thereon, shall be allowed a fair and reasonable compensation for the material so taken or for any injuries the lands or crops may sustain in consequence of the making of such drains or ditches. The amount of such compensation shall be determined, allowed and paid by the highway commissioners in event such material is used upon a mail route or a township road, and determined, allowed and paid by the board of county commissioners of the county when such material is used upon a county or state road. Such claims shall be allowed and paid in the same manner as other ordinary claims against the county or township and the claimant shall have the same right of appeal as is now provided by law in other cases.

(b) If the owner of any property adjacent to or abutting a township road which has been laid out but not opened prior to the effective date of this act desires to have such road

opened, it shall be the duty of such owner to open such road. Such property owner shall establish a maintainable road bed and drainage in accordance with the standards established by the township board pursuant to K.S.A. 68-115a, and amendments thereto. Thereafter, it shall be the duty of the township board to maintain such road as required by subsection (a).

If the owner of any property adjacent to or abutting a township road which has been opened prior to the effective date of this act, but such road has not been maintained by the township for at least 20 years or has not been regularly used by the general public and the owner desires to have the road maintained for general public use, it shall be the duty of such owner to establish a maintainable road bed and drainage in accordance with the standards established by the township board pursuant to K.S.A. 68-115a, and amendments thereto. Thereafter, it shall be the duty of the township board to maintain such road as required by subsection (a).

If there is a dispute between landowners regarding the location of a township road, the county engineer shall determine the location of the road.

Sec. 8. K.S.A. 68-115 is hereby repealed.";

And by renumbering the remaining section accordingly;

In the title, in line 10, preceding the period by inserting "; concerning the opening of certain roads; amending K.S.A. 68-115 and repealing the existing section"; and the bill be passed as amended.

Committee on **Transportation** recommends **SB 211** be amended on page 1, following the enacting clause by inserting the following:

"Section 1. K.S.A. 8-2502 is hereby amended to read as follows: 8-2502. As used in this act, "passenger car" means a motor vehicle, manufactured or assembled after January 1, 1968, or a motor vehicle manufactured or assembled prior to 1968 which was manufactured or assembled with safety belts, with motive power designed for carrying 10 passengers or fewer, including vans, but does not include a motorcycle, a trailer or a vehicle constructed either on a truck chassis registered for a gross weight of more than 12,000 pounds or a farm truck registered for a gross weight of more than 16,000 pounds or a vehicle constructed with special features for occasional off-road operation or a motor-driven cycle.";

And by renumbering the remaining sections accordingly;

Also on page 1, in line 17, by striking "Section" and inserting "Sec.";

On page 2, in line 18, by striking all following "fined"; in line 19, by striking "court costs" and inserting "\$60"; in line 21, by striking "not"; in line 22, by striking all preceding the period and inserting "\$60";

On page 5, in line 17, after the first "K.S.A." by inserting "8-2502,";

In the title, in line 12, after "K.S.A." by inserting "8-2502,"; and the bill be passed as amended.

Upon unanimous consent, the House referred back to the regular order of business, Introduction of Bills and Concurrent Resolutions.
