# SIXTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Tuesday, January 16, 2007—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with forty senators present. Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

As we commemorate Dr. Martin Luther King, Jr's birthday anniversary, remind us of some of the quotations from him and other prominent black Americans which point out their spiritual orientation:

Dr. King was a Baptist preacher who, in a speech on December 31, 1955, said, "If you will protest courageously, and yet with dignity and Christian love, when the history books are written in future generations, the historians will have to pause and say, "There lived a great people—a black people—who injected new meaning and dignity into the veins of civilization."

Harriet Tubman, a former slave who repeatedly risked her life to free over 300 slaves, told her biographer in 1868, "Twant me, 'twas the Lord. I always told Him, 'I trust to You. I don't know where to go or what to do, but I expect You to lead me,' and He always did."

Frederick Douglass, a former slave, became an outstanding abolitionist and spokesman for all slaves. While retelling the story of his conversion, he said, "...I gathered scattered pages of the Bible from the filthy street gutters, and washed and dried them, that in moments of leisure I might get a word or two of wisdom from them."

Booker T. Washington, once a slave, became one of America's greatest reformers, educators and writers, once declared, "I shall allow no man to belittle my soul by making me hate him."

George Washington Carver, who was a agricultural chemist of international fame, introduced hundreds of uses for the peanut, soybean, pecan and sweet potato, which revolutionized the economy of the South. In 1928 he was asked to share some of his observations about God, and part of his response follows: "My purpose alone must be God's purpose—to increase the welfare and happiness of His people...should we who believe in Christ be so surprised at what God can do with a willing man in a laboratory? Some things must be baffling to the critic who has never been born again."

So thank You, Lord, for these and other remarkably courageous individuals who have blessed this nation, and brought honor and glory to You.

# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senators Brownlee and Lynn introduced the following Senate resolution, which was read: SENATE RESOLUTION No. 1807—

A RESOLUTION congratulating and commending the members of the 2007 Kansas Teacher of the Year Team.

WHEREAS, The Kansas State Department of Education sponsors the Kansas Teacher of the Year program which identifies, recognizes and utilizes representatives of excellent teaching in the elementary and secondary classrooms of the state. The mission of the program is to build and utilize a network of exemplary teachers who are leaders in the improvement of schools, student performance and the teaching profession; and

WHEREAS, Two teachers—one elementary and one secondary—in each of the state's four United States congressional districts were selected as finalists for recognition as Kansas Teacher of the Year, the Kansas Teacher of the Year being chosen from among the eight finalists. Collins, Morris County USD 417; Lori Atkins Goodson, Wamego USD 320; Martha Hadsall, Anthony-Harper USD 361; Bonnie Kastanek, Manhattan-Ogden USD 383; Carrie Mugridge, DeSoto USD 232; DeAnn R. Nelson, Wichita USD 259; and Sheryl L. Smith, Buhler USD 313: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend the members of the 2007 Kansas Teacher of the Year Team and wish Mr. Anderson success in the national competition; and

Be it further resolved: That the Secretary of the Senate provide eight enrolled copies of this resolution to the Commissioner of Education for forwarding to the members of the 2007 Kansas Teacher of the Year Team.
