# TWENTY-THIRD DAY

Senate Chamber, Topeka, Kansas Thursday, February 8, 2007—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-nine senators present. Senator Donovan was excused. Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

## INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Schodorf introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1816-

A RESOLUTION congratulating and commending the 2007 Horizon Award Program educators.

WHEREAS, Thirty-two beginning educators from across the state have been named as Kansas Horizon Award educators; and

WHEREAS, The Kansas Horizon Award program, sponsored by the Kansas State Department of Education, identifies and recognizes representatives of excellent teaching in the elementary and secondary classrooms of the state. The mission of the Kansas Horizon Award program is to recognize exemplary first-year teachers who perform in a way that distinguishes them as outstanding; and

WHEREAS, The Kansas Horizon Award program, currently in its fifth year, allows all school districts in the state an opportunity to nominate one elementary and one secondary teacher for the award. To be eligible for a Kansas Horizon Award, teachers must have successfully completed their first year of teaching and have performed in such a way as to distinguish themselves as outstanding. The Kansas Horizon Award program is a regional competition with four regions corresponding to the state's United States congressional districts. Four elementary and four secondary classroom teachers may be selected for the award from each district; and

Committee on Ways and Means introduced the following Senate resolution, which was read:

## SENATE RESOLUTION No. 1817—

A RESOLUTION urging the United States Senate to fulfill the requests of the 2005 BRAC Commission and the United States Military by restoring federal funds for military construction in the Federal Continuing Resolution to the funding levels agreed upon in the FY 2007 Defense Authorization Bill.

WHEREAS, Kansas communities, state officials and the members of the Kansas Congressional Delegation worked hard and the results of the 2005 Base Realignment and

Closure (BRAC) Commission recommendations were the best news for Kansas in years; and

WHEREAS, These recommendations are resulting in significant increases in personnel and the missions assigned to Fort Riley, Fort Leavenworth, Forbes Air Force Base and McConnell Air Force Base in Kansas; and

WHEREAS, The military commands, the troops and their families coming to work on those missions are facing a situation with much of the funding support originally contained in the Federal Continuing Resolution, and many of the key projects in Kansas, now at risk; and

WHEREAS, The Federal Continuing Resolution adopted by the United States' House of Representatives currently provides less than half of the request for the 2005 BRAC Commission and is more than \$3 Billion short of the amount agreed upon in the FY 2007 Defense Authorization Bill; and

WHEREAS, Kansas Governor Kathleen Sebelius' Military Council voted on February 7, 2007, to support efforts to restore vital federal military construction funding for Fort Riley, Fort Leavenworth, Forbes Air Force Base and McConnell Air Force Base at this time when these military posts are getting new missions; and

WHEREAS, Projects that are potentially at risk at Fort Riley include a Combat Aviation Brigade complex, which would provide additional housing for troops, headquarters and operations buildings and facilities, hanger expansion and a crash rescue fire station (\$152 Million); essential Runway Improvements (\$17 Million); Division Headquarters and Sustainment Brigade Headquarters buildings and facilities (\$87 Million); a state-of-the-art Battle Command Training Center (\$27 Million); and a Health and Dental Clinic (\$17.5 Million) and a Child Development Center (\$5.7 Million) to serve the thousands of troops and their families moving to Fort Riley; and

WHEREAS, The project for the Joint Regional Corrections Facility (\$68-\$95 Million) at Fort Leavenworth is also at risk; and

WHEREAS, The Senate of the State of Kansas considers the federal funding requested for Fort Riley, Fort Leavenworth, Forbes Air Force Base and McConnell Air Force Base, based on the recommendations of the 2005 BRAC Commission, to be crucially important to the United States of America, as well as to the State of Kansas: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That the Senate of the Legislature of the State of Kansas strongly urges the United States Senate to fulfill the requests of the 2005 BRAC Commission and the United States Military by restoring federal funds for military construction in the Federal Continuing Resolution to the funding levels agreed upon in the FY 2007 Defense Authorization Bill; and

Be it further resolved: That the Secretary of State is directed to send enrolled copies of this resolution to the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives, and to each member of the Kansas Congressional Delegation.

Senator Emler amended SR 1817 on page 2, in the last paragraph, 3rd line, by striking "President" and inserting "Majority Leader", and the amendment was adopted by voice vote

On emergency motion of Senator Emler SR 1817 was adopted unanimously.

"(b) "Business building insurance" means a policy providing property coverage on business buildings and structures for the perils of fire and lightning and additional coverages.":

By relettering the remaining subsections accordingly;

Also on page 1, in line 30, following the comma by inserting "gypsum mines"; in line 37, following "homeowners," by inserting "business building"

On page 2, in line 11, by striking all following "the"; in line 12, by striking all preceding "designee" and inserting "the commissioner of insurance or the commissioner's"; in line 13, by striking "commissioner of insurance or the com-"; in line 14, by striking "missioner's" and inserting "secretary of health and environment or the secretary's"; in line 22, by striking "contract with the"; in line 23, by striking all preceding "for" and inserting "contracts";

On page 3, in line 39, by striking "Kansas insurance guaranty association or its members" and inserting "contractors or vendors employed by the mine subsidence governing board";

On page 4, in line 2, by striking "Kansas insurance"; in line 3, by striking "guaranty association" and inserting "vendor hired"; in line 4, by striking "with"; in line 5, by striking all preceding "for"; in line 7, by striking "Kansas insurance guaranty association" and inserting "vendor";

On page 5, following line 17, by inserting the following:

"(c) Before any mine subsidence insurance coverage can be issued, an inspection must be performed to document the integrity of insured structures to identify any existing damage to be excluded from coverage.";

And the bill be passed as amended.

Committee on Judiciary recommends SB 41, SB 54, SB 87 be passed.

Also, **SB 74** be amended on page 2, in line 3, by striking all following "states"; in line 4, by striking all preceding the period;

On page 4, in line 42, by striking all following "(h)"; by striking all in line 43;

On page 5, by striking all in lines 1 through 8 and inserting "The court may issue a final order of allowance and settlement upon the filing of a final accounting and a finding by the court that the following have occurred:

- (1) Reimbursement to the appropriate agency for any medical assistance payments, if any, received under subsection (e) of K.S.A. 39-709, and amendment thereto, or any similar laws of any other state for or on behalf of a conservatee or a predeceased spouse of the conservatee, but only to the extent allowed by law;
- (2) delivery of any remaining funds and assets of the conservatee's estate to the person or persons entitled to such funds or assets; and
- (3) presentation to the court of receipts for subsections (1) and (2).

The conservator, the conservator's estate and the conservator's surety shall be released upon the issuance of the court's final order of allowance and settlement.";

And the bill be passed as amended.

**SB 97** be amended on page 5, in line 41, by striking "third or subsequent"; in line 42, by striking "or 21-3716"; and the bill be passed as amended.

**SB** 103 be amended on page 2, in line 3, by striking "may" and inserting "shall"; in line 14, before the period, by inserting ", except after an escape and when necessary to assist in apprehension"; in line 21, before the semicolon, by inserting "or (a)(4)"; and the bill be passed as amended.

Committee on Natural Resources recommends SB 188 be passed.

Also, **SB 191** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

SB 146 be amended on page 2, in line 13, by striking "unit" and inserting "units"; also in line 13, by striking "75%" and inserting "50%"; in line 14, by striking "and install"; also in line 14, following "cover" by inserting "or other tire derived"; in line 15, following the period by inserting "As used in this section, "tire derived products" means athletic field surfacing, playground cover, horticulture products and molded or extruded rubber products made from recycled waste tires."; and the bill be passed as amended.

SB 192 be amended on page 1, in line 16, by striking "on" and inserting "or"; and the bill be passed as amended.

Senator Haley further moved to amend  $\bf SB~160$  as amended by Senate Committee, on page 10, after line 39, by inserting the following:

"New Sec. 15. (a) Notwithstanding any other provision of law, no electronic or electromechanical voting system shall be approved for use in this state unless such electronic or electromechanical voting system provides for a paper record of each electronically generated ballot that can be:

- (1) Reviewed and corrected by the voter at the time the vote is cast; and
- (2) used for a recount of the votes cast at an election in which electronically generated ballots are used.
- (b) (1) On and after January 1, 2008, no electronic or electromechanical voting system shall be used in this state unless such voting system has an accessible voter verified paper audit trail
- (2) For the purposes of this provision, "accessible voter verified paper audit trail" means a component of a direct recording electronic voting system that prints a contemporaneous paper record copy of each electronic ballot and allows each voter to confirm such voter's selections before the voter casts such voter's ballot.";
