SENATE CHAMBER, TOPEKA, KANSAS Wednesday, February 14, 2007—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-nine senators present. Senator Brownlee was excused. Invocation by Chaplain Fred S. Hollomon:

SB 348, An act relating to merchants; prohibiting certain changes by credit or debit card issuers, by Committee on Federal and State Affairs.

SB 349, An act relating to merchants; prohibiting transaction charges on credit or debit cards, by Committee on Federal and State Affairs.

SB~350, An act relating to merchants; providing for access to certain credit and debit card rate information, by Committee on Federal and State Affairs.

SB 351, An act concerning the office of the state bank commissioner; relating to the office of administrative hearings; exception; amending K.S.A. 2006 Supp. 75-37,121 and repealing the existing section, by Committee on Federal and State Affairs.

HB 2014, HB 2031, HB 2106; Substitute HB 2108; HB 2111, HB 2145, HB 2306 were thereupon introduced and read by title.

REPORTS OF STANDING COMMITTEES

Committee on Education recommends SB 144 be passed.

Committee on **Federal and State Affairs** recommends **HB 2152** be amended on page 1, in line 35, before the semicolon, by inserting ", one of which represents broadcasting"; and the bill be passed as amended.

Committee on **Judiciary** recommends **SB 17** be amended on page 2, after line 8, by inserting the following:

- "(d) To the state treasurer, in accordance with the provisions of K.S.A. 75-4215, and amendments thereto, for deposit in the state treasury and credit to the indigents' defense services fund, a sum equal to \$.50 for each docket fee paid pursuant to K.S.A. 28-172a and subsection (d) of K.S.A. 28-170, and amendments thereto, during the preceding calendar month.
- (e) To the state treasurer, in accordance with the provisions of K.S.A. 75-4215, and amendments thereto, for deposit in the state treasury and credit to the law enforcement training center fund a sum equal to \$15 for each docket fee paid pursuant to K.S.A. 28-172a, and amendments thereto, during the preceding calendar month.
- (f) Prior to any of the moneys credited to each fund in subsection (d) or (e) being appropriated during any regular legislative session for the ensuing fiscal year, the agency administering such fund shall provide to the committee on ways and means of the senate and the committee on appropriations of the house of representatives:
- (1) A detailed explanation of how such moneys in the fund are being expended in the current fiscal year;
- (2) a detailed explanation of how such moneys will be expended in the next fiscal year; and
 - (3) justification for such fund to continue to receive moneys from docket fees.";

Also on page 2, in line 9, by striking "(d)" and inserting "(g)"; in line 14, by striking "and (c)" and inserting "(c), (d) and (e)"; in line 18, by striking "(d)" and inserting "(g)";

On page 3, in line 37, by striking "and"; also after line 37, by inserting the following:

- "(8) 2.73% to the juvenile detention facilities fund;
- (9) 0.56% to the crime victims assistance fund;
- (10) 1.24% to the Kansas juvenile delinquency prevention trust fund;
- (11) 0.21% to the permanent families account in the family and children investment fund;
- (12) 1.48% to the trauma fund;

- (13) 0.67% to the child exchange and visitation centers fund;
- (14) 2.68% to the protection from abuse fund; and";

Also on page 3, in line 38, by striking "(8)" and inserting "(15)"; in line 41, by striking "(d)" and inserting "(g)";

On page 4, in line 5, by striking "and"; also after line 5, by inserting the following:

- "(7) 2.83% to the juvenile detention facilities fund;
- (8) 0.58% to the crime victims assistance fund;
- (9) 2.78% to the protection from abuse fund;
- (10) 1.29% to the Kansas juvenile delinquency prevention trust fund;
- (11) 0.22% to the permanent families account in the family and children investment fund;
- (12) 1.53% to the trauma fund;

(13) 0.69% to the child exchange and visitation centers fund; and";

Also on page 4, in line 6, by striking "(7)" and inserting "(14)"; also after line 6, by inserting the following:

"(c) Prior to any moneys credited to each fund in paragraphs (8) through (14) of subsection (a) and paragraphs (7) through (13) of subsection (b) being appropriated during any regular legislative session for the ensuing fiscal year, the agency administering such fund shall provide the committee on ways and means of the senate and the committee on appropriations of the house of representatives:

(1) A detailed explanation of how such moneys are being expended in the current fiscal

year;

(2) a detailed explanation of how such moneys will be expended in the next fiscal year; and

(3) justification for such fund to continue to receive moneys from docket fees.";

On page 5, in line 10, after the stricken material by inserting "In actions pursuant to the revised Kansas code for care of children (K.S.A. 2006 Supp. 38-2201 et seq., and amendments thereto), the revised Kansas juvenile justice code (K.S.A. 2006 Supp. 38-2301 et seq., and amendments thereto), the act for treatment of alcoholism (K.S.A. 65-4001 et seq., and amendments thereto), the act for treatment of drug abuse (K.S.A. 65-5201 et seq., and amendments thereto), or the care and treatment act for mentally ill persons (K.S.A. 59-945 et seq., and amendments thereto), the clerk shall charge an additional fee of \$.50 which shall be deducted from the docket fee and credited to the indigents' defense services fund as provided in K.S.A. 28-172b, and amendments thereto."; in line 11, before "The" by inserting "(e)";

On page 6, in line 21, before "the" by inserting "the law enforcement training center fund,"; in line 22, before "the" by inserting "the juvenile detention facilities fund,"; in line 23, before "and" by inserting ", the emergency medical services operating fund"; in line 26, before the period by inserting ", the family violence and child abuse and neglect assistance and prevention fund fee shall be paid from criminal proceedings docket fees";

On page 7, in line 11, by striking all after the period; by striking all in line 12"; after line 23, by inserting the following:

"(b) The clerk of the district court shall charge a fee of \$.50 in each criminal case, to be deducted from the docket fee as provided in K.S.A. 28-172a, and amendments thereto, and shall charge a fee of \$.50 in each case pursuant to the revised Kansas code for care of children or the revised Kansas juvenile justice code and each mental illness, drug abuse or alcoholism treatment action as provided by subsection (d) of K.S.A. 28-170, and amendments thereto. The clerk of the district court shall remit all such fees received to the state treasurer in accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the indigents' defense services fund.";

Also on page 7, in line 24, by striking "(b)" and inserting "(c)";

On page 9, by striking all in lines 27 through 43;

By striking all on pages 10 through 13;

On page 14, by striking all in lines 1 through 24;

And by renumbering the remaining sections accordingly;

Also on page 14, in line 25, by striking "K.S.A. 74-7325 and 74-7334 and"; in line 28, by striking all after "60-1621"; in line 29, by striking "75-7021" and inserting "and 60-1621a";

In the title, in line 9, by striking all after "amending"; in line 10, by striking "and"; in line 11, by striking ", 60-1621, 75-5670 and 75-7021" and inserting "and 60-1621"; and the bill be passed as amended.

Committee on Public Health and Welfare recommends SB 178 be passed.

Also, **SB 107** be amended on page 1, in line 14, preceding "applicant" by inserting "original"; and the bill be passed as amended.

SB 179 be amended on page 1, in line 26, by striking "with" and inserting "on successful completion of an"; in line 27, following the comma by inserting "and";

On page 2, in line 34, following "examination" by inserting "and education"; and the bill be passed as amended.

Committee on **Utilities** recommends **SB 326** be amended on page 2, in line 37, by striking "energy" and inserting "emergency"; and the bill be passed as amended.
