REPORTS OF STANDING COMMITTEES

The Committee on **Agriculture** recommends **HB 2208** be amended on page 1, in line 18, by striking "Terms shall run"; in line 19, by striking all before "At"; in line 22, by striking all after the period; by striking all of line 23; in line 24, by striking all before "Any"; in line 25, by striking "to at large" and inserting "for"; in line 37, before the period, by inserting "commencing January 1 and ending December 31"; and the bill be passed as amended.

The Committee on **Commerce** recommends **SB** 316 be amended by substituting a new bill as recommended by the Senate Committee on Commerce as reported in the Journal of the Senate on February 21, 2007, and the substitute bill be amended by substituting a new bill to be designated as "Substitute for Substitute for SENATE BILL No. 316," as follows:

"Substitute for Substitute for SENATE BILL No. 316

By Committee on Commerce

"AN ACT concerning economic development; relating to tax increment financing and sales tax and revenue bonds; establishing the STAR bond financing act; amending K.S.A. 12-1770 and 12-1776 and K.S.A. 2006 Supp. 12-1770a, 12-1771, 12-1771b, 12-1773, 12-1774 and repealing the existing sections; also repealing K.S.A. 2006 Supp. 12-1773, as amended by section 3 of chapter 192 of the 2006 Session Laws of Kansas, 12-1771d, 12-1780b, 12-1780c, 12-1780d, 12-1780e and 12-1780f."; and the substitute bill be passed.

Also, **SB** 333 be amended on page 1, in line 15, by striking "building"; in line 23, after "building" by inserting "water and waste water treatment facilities";

On page 2, after line 6, by inserting the following:

"(i) "Undisputed payment" means payments which all parties to the contract agree are owed to the contractor.";

Also on page 2, in line 32, before the comma, by inserting "according to terms of the contract"; in line 36, after "record", by inserting "or agent of the owner"; in line 38, before the period, by inserting "of receipt from the contractor";

On page 3, in line 13, by striking "5%" and inserting "10%"; in line 14, by striking all after "due"; by striking all in line 15; in line 16, by striking all before the period; in line 17, before "An", by inserting "(b)";

And by relettering the remaining subsections accordingly;

Also on page 3, in line 22, by striking all after the period; by striking all of line 23 and 24; in line 35, by striking "to the owner. The" and inserting "or additional cost to the owner or contractor. Once so determined, the";

On page 4, in line 11, by striking the second comma; in line 22, by striking "building"; in line 26, before the period, by inserting "or any subsequent editions";

On page 1, in the title, in lines 9 and 10, by striking "building"; and the bill be passed as amended.

Committee on Elections and Local Government recommends SB 136 be passed.

Committee on **Federal and State Affairs** recommends **SB 194** be amended by substituting a new bill to be designated as "Substitute for SENATE BILL No. 194," as follows:

"Substitute for SENATE BILL No. 194 By Committee on Federal and State Affairs

"AN ACT concerning public information.";

and the substitute bill be passed.

Also, **SB 321** be amended on page 1, in line 26, before the period, by inserting "and within five miles of the corporate limits along the Marmaton river"; in line 28, by striking "Kansas" and inserting "Marmaton"; in line 35, by striking "but"; in line 36, by striking all before the period; and the bill be passed as amended.

Committee on Natural Resources recommends HB 2168, as amended by House Committee, be passed.

Committee on **Public Health and Welfare** recommends **HB 2096**, **HB 2181**, **HB 2182** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.
