## INTRODUCTION OF ORIGINAL MOTIONS AND HOUSE RESOLUTIONS

The following resolutions were introduced and read by title:

HOUSE RESOLUTION No. 6008-

By Representatives Ward, Crow, Dillmore, Faust-Goudeau, Garcia, Henry, McKinney and Sawyer

A RESOLUTION urging the Congress of the United States to expedite citizenship for immigrants who serve honorably in the United States Armed Forces.

WHEREAS, In times of war, immigrants have the same obligations to defend this country as native-born citizens; and

WHEREAS, Lawful permanent residents and naturalized citizens are equally subject to the draft; and

WHEREAS, Immigrants, like native citizens, have expressed their loyalty to this country by serving voluntarily in the United States Armed Forces; and

WHEREAS, Historically, immigrants have made remarkable contributions to our nation's military strength through their knowledge, energy and courageous actions; and

WHEREAS, Over 62,000 immigrants serve on active duty in today's all-volunteer military, comprising 4.8 percent of all enlisted personnel on active duty in the United States Armed Forces; and

WHEREAS, Of the millions who have served in the United States Armed Forces, only a few thousand have received the Medal of Honor; however, more than 20 percent of the total number of Medal of Honor recipients, 715 out of 3,405 are immigrants; and

WHEREAS, In 2002, President Bush signed Executive Order 13269 which makes those persons serving honorably in active-duty status in the United States Armed Forces eligible for certain statutory exceptions to the naturalization requirements, however the Congress has yet to pass any legislation to designate a time frame for expedited citizenship applications: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we urge the Congress of the United States to recognize the contribution made by immigrants who have expressed their loyalty to this country by expediting citizenship for those immigrants who serve honorably in the United States Armed Forces; and

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives and to each member of the Kansas Congressional Delegation.

HOUSE RESOLUTION No. 6009-

By Representatives Ward, Davis, Dillmore and Henry

A RESOLUTION urging the Congress of the United States to control the borders, prevent illegal immigration and alleviate the logistical and financial burden currently resting on states and private businesses.

WHEREAS, Currently, 1.6 million legal and illegal immigrants arrive in the United States each year and only 350,000 immigrants leave each year, resulting in net immigration of 1.25 million legal and illegal immigrants in the United States each year; and

WHEREAS, Recent government and academic estimates indicate there are between 10 million and 13 million illegal immigrants currently living in the United States, with nearly 90,000 residing in the state of Kansas; and

WHEREAS, The federal government's E-verify, the free system that allows employers to confirm the legal working status of employees, is not mandatory for all employers; and

WHEREAS, Federal law requires states to provide free emergency medical care for the poor, as well as free K-12 education to all children, regardless of immigration status; and

WHEREAS, Twice in the last two years, efforts by Congress to overhaul the nation's immigration laws have failed, leaving the burden on states to provide solutions for the myriad problems arising from illegal immigration; and

WHEREAS, Many states have attempted to address the problem of illegal immigration, which has resulted in a patchwork of laws that are difficult for citizens to comply with and typically shift the burden to surrounding states; and

WHEREAS, Enforcement of federal immigration laws is a federal responsibility and should remain so; and

WHEREAS, The burden of incarcerating unauthorized immigrants who have committed crimes, been convicted and are serving time in state and local jails should be fully borne by the federal government; and

WHEREAS, The federal government should ensure that state and local governments have a reliable, guaranteed funding source to manage the fiscal impacts of providing health, education and social services to immigrant populations, including temporary and guest workers: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we urge the Congress of the United States to control the borders and address the burden placed on states by immigrants accessing health care, public education and other social services, by expediting the E- verify system and appropriating sufficient funds to enforce current laws that return illegal immigrants to their country of origin; and

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives and to each member of the Kansas Congressional Delegation.
