## INTRODUCTION OF ORIGINAL MOTIONS AND HOUSE RESOLUTIONS

The following resolution was introduced and read by title:

HOUSE RESOLUTION No. 6013-

## By Representative Mast

A RESOLUTION condemning harmful gangsta rap lyrics which have a detrimental effect on families and communities, and a demoralizing message against women and minorities.

WHEREAS, Gangsta rap conveys messages that have a harmful impact on more individuals than just those who listen to it; it encourages violent and disrespectful behavior that devalues families and communities, and it infringes on the dignity of women; and

WHEREAS, Gangsta rap is widely criticized as an expression of anti-culture for its frequent reliance on messages that demean women and promote violence, but its continued popularity prevents many women and community leaders from speaking out against the negative stereotypes it perpetuates; and

WHEREAS, Individuals who are opposed to the misogynistic, sexist and racist lyrics of gangsta rap can make their voices heard by demonstrating against, and refusing to support, those who are unjustly enriched by it; and

WHEREAS, The First Amendment provides important protection for the freedom of speech by those in the entertainment industry, but gangsta rap abuses those rights by denigrating women and promoting stereotypes merely for the sake of financial profit; and

WHEREAS, Individuals are encouraged to protect themselves and their communities from the negative effects of gangsta rap by increasing awareness and reducing demand for this type of music; and

WHEREAS, As awareness increases regarding the negative effects gangsta rap has on communities, women and community leaders will feel empowered to speak out against hateful and derogatory lyrics in rap and to educate our youth about the dangers of perpetuating such negative stereotypes in our popular culture; and

WHEREAS, Rap music has always been associated with artistic creativity and innovation, and rappers are certainly capable of becoming positive role models, cleaning up their music, eliminating misogynistic and racist lyrics and replacing them with uplifting messages while maintaining a high level of entertainment in their songs; and

WHEREAS, Surely the words used to denigrate women and incite violence can be rewritten to encourage respect for women, families and communities: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we desire to empower women to defend themselves against the negative stereotypes depicted in gangsta rap and encourage community leaders to make efforts to combat the harmful effects of gangsta rap without infringing on the First Amendment rights of those in the entertainment industry; and

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to Representative Mast for presentation to Sonny Scroggins.

Committee on **Agriculture and Natural Resources** recommends **HCR 5028** be amended on page 2, by striking all in lines 1 through 3 and inserting the following:

"Be it further resolved: That members of this partnership shall enter into suitable arrangements with the State of Kansas to jointly develop and implement plans to sustain the reservoirs beyond their original design lives. Such plans shall consider the need for future flood protection, water supply and reasonable recreational opportunities; and";

Also on page 2, in line 4, by striking "amend" and inserting "determine needed amendments to"; in line 7, after "lives" by inserting "and shall report needed amendments to the Kansas legislature and the United States Congress by January, 2009"; in line 13, by striking "amend" and inserting "determine needed amendments to"; in line 19, before the semicolon, by inserting "and shall report needed amendments to the Kansas legislature and the United States Congress by January, 2009"; and the concurrent resolution be adopted as amended

Committee on **Energy and Utilities** recommends **HB 2892** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

Committee on **Government Efficiency and Technology** recommends **HB 2207** be amended by substituting a new bill to be designated as "Substitute for HOUSE BILL No. 2207," as follows:

"Substitute for HOUSE BILL No. 2207

By Committee on Government Efficiency and Technology

"AN ACT concerning the Kansas board of pharmacy; authorizing emergency proceedings against permits and registrations; amending K.S.A. 2007 Supp. 65-1627 and repealing the existing section."; and the substitute bill be passed.

(Sub. HB 2207 was thereupon introduced and read by title.)

Committee on **Health and Human Services** recommends **HB 2781** be amended on page 2, in line 15, by striking "one dental office" and inserting "two dental offices"; in line 17, by striking "75" and inserting "125"; and the bill be passed as amended.

Committee on **Judiciary** recommends **HB 2644** be amended on page 1, after line 14, by inserting the following:

"Section 1. K.S.A. 59-3051 is hereby amended to read as follows: 59-3051. When used in the act for obtaining a guardian or a conservator, or both:

(a) "Adult with an impairment in need of a guardian or a conservator, or both" means a person 18 years of age or older, or a minor who is considered to be of the age of majority pursuant to K.S.A. 38-101, and amendments thereto, or upon whom the rights of majority have been conferred pursuant to K.S.A. 38-108, and amendments thereto, whose ability to receive and evaluate relevant information, or to effectively communicate decisions, or both, even with the use of assistive technologies or other supports, is impaired such that the person lacks the capacity to manage such person's estate, or to meet essential needs for physical health, safety or welfare, and who is in need of a guardian or a conservator, or both. No person who is being treated by prayer in the practice of the religion of any church which teaches reliance on spiritual means alone through prayer for healing shall be determined to be an adult with an impairment in need of a guardian under this act for that reason alone,

nor considered to lack the capacity to meet essential needs for physical health, safety or welfare because of such person's reliance upon such treatment.

- (b) "Appropriate alternative" means any program or service, or the use of a legal device or representative, which enables a person with an impairment to adequately meet essential needs for physical health, safety or welfare, or to reasonably manage such person's estate. Appropriate alternatives may include, but are not limited to, a power of attorney, a durable power of attorney, a power of attorney for health care decisions, a living will, a trust, a joint tenancy or a representative payee.
  - (c) "Conservatee" means a person who has a conservator.
- (d) "Conservator" means an individual or a corporation who or which is appointed by the court to act on behalf of a conservatee and who or which is possessed of some or all of the powers and duties set out in K.S.A. 59-3078, and amendments thereto.
- (e) "Guardian" means an individual or a corporation certified in accordance with K.S.A. 59-3070, and amendments thereto, who or which is appointed by a court to act on behalf of a ward, and who or which is possessed of some or all of the powers and duties set out in K.S.A. 59-3075, amendments thereto. "Guardian" does not mean a "natural guardian" unless specified.
- (f) "In need of a guardian" means a person who because of both an impairment and the lack of appropriate alternatives for meeting essential needs, requires the appointment of a guardian.
- (g) "In need of a conservator" means a person who because of both an impairment and the lack of appropriate alternatives for managing such person's estate, requires the appointment of a conservator.
- (h) "Manage such person's estate" means making those determinations and taking those actions which are reasonably necessary in order for a person to receive and account for personal or business income, benefits and property, whether real, personal or intangible, and except for reasons of indigency, to purchase or otherwise obtain necessary goods or services, to pay debts and expenses, to sell, exchange or otherwise dispose of property, and to plan for future accumulation, conservation, utilization, investment, and other disposition of financial resources.
- (i) "Meet essential needs for physical health, safety or welfare" means making those determinations and taking those actions which are reasonably necessary in order for a person to obtain or be provided with shelter, sustenance, personal hygiene or health care, and without which serious illness or injury is likely to occur.
- (j) "Minor" means any person defined by K.S.A. 38-101, and amendments thereto, as being within the period of minority.
- (k) "Minor with an impairment in need of a guardian or a conservator, or both" means a person under 18 years of age who otherwise meets the definition of an "adult with an impairment in need of a guardian or conservator, or both" and whose impairment is expected to continue beyond the age of 18.
- (l) "Natural guardian" means both the biological or adoptive mother and father of a minor if neither parent has been found to be an adult with an impairment in need of a guardian or has had parental rights terminated by a court of competent jurisdiction. If either parent of a minor is deceased, or has been found to be an adult with an impairment in need of a guardian or has had parental rights terminated by a court of competent jurisdiction, then the other parent shall be the natural guardian, unless also deceased, or found to be an adult with an impairment in need of a guardian, or has had parental rights terminated by a court of competent jurisdiction, in which case no person shall qualify as the natural guardian.
- (m) "Person who has been previously adjudged as impaired in another state" means a person who has been duly adjudged by a court of competent jurisdiction of any other state to be unable to meet essential needs for physical health, safety or welfare or to manage such person's estate and for whom a guardian or a conservator, or other similarly empowered fiduciary, has been appointed by that court, but who now resides within Kansas or for whom plans have been made by such person's guardian or other fiduciary to relocate the person to Kansas
- (n) "Person in need of an ancillary conservator" means a person not residing within Kansas, who has been duly adjudged by a court of competent jurisdiction of another state

to be unable to manage such person's estate and for whom a conservator or other fiduciary of the person's estate has been appointed by that court, and who has property in Kansas for which a conservator is required.

- (o) "Proposed ward" means a person for whom a petition for the appointment of a guardian pursuant to K.S.A. 59-3058, 59-3059, 59-3060 or 59-3061, and amendments thereto, has been filed.
- (p) "Proposed conservatee" means a person for whom a petition for the appointment of a conservator pursuant to K.S.A. 59-3058, 59-3059, 59-3060, 59-3061 or 59-3062, and amendments thereto, has been filed.
  - (q) "Ward" means a person who has a guardian.
- (r) The terms defined in K.S.A. 59-2946 and 59-29b46, and amendments thereto, have the meanings provided by those statutes.
- (s) "Personal or agency interest" shall include, but not be limited to, details of any financial, agency or other transactions between a proposed guardian, guardian, proposed conservator or conservator and the proposed ward, ward, proposed conservatee or conservatee as
