COMMITTEE OF THE WHOLE

On motion of Rep. Bethell, Committee of the Whole report, as follows, was adopted: Recommended that **HB 2660**, **HB 2681** be passed.

On motion of Rep. Hodge to refer **HB 2771** to Committee on Federal and State Affairs, the motion did not prevail and the bill be passed.

Committee report to **HB 2628** be adopted; and the bill be passed as amended.

Committee report to **HB 2726** be adopted; also, on motion of Rep. Holland to amend, the motion was withdrawn and the bill be passed as amended.

REPORTS OF STANDING COMMITTEES

Committee on **Energy and Utilities** recommends **HB 2698** be amended on page 2, after line 13, by inserting the following:

"(7) "Robo-call" means a telephone call to a residential telephone number using an artificial or prerecorded voice to deliver a message without the prior express consent of the called party, unless the call is initiated for emergency purposes.";

Also on page 2, in line 16, after "8 a.m." by inserting "central time";

On page 3, after line 3, by inserting the following:

"(f) A robo-call shall not be placed between the hours of 8 p.m. and 8 a.m. central time. Any person alleging a violation of this subsection may bring a private action to seek relief pursuant to K.S.A. 50-634, 50-636 and 50-6,104, and amendments thereto, and such person may be defined as a consumer pursuant to K.S.A. 50-624, and amendments thereto, for the purposes of such private action.";

By relettering the remaining subsections accordingly;

On page 1, in the title, in line 9, by striking "automated" and inserting "unsolicited"; and the bill be passed as amended.

Committee on **Government Efficiency and Technology** recommends **HB 2758** be amended on page 1, in line 42, after "on" by inserting "or while utilizing"; and the bill be passed as amended.

Committee on **Health and Human Services** recommends **HB 2570** be amended on page 1, in line 14, by striking "2006" and inserting "2007"; in line 17, by striking all after "assessment"; by striking all in lines 18 through 27 and inserting "of the advisability of the adoption by a court approved:

- (1) (A) Licensed social worker, licensed specialist social worker, licensed specialist clinical social worker, licensed masters social worker, licensed baccalaureate social worker or licensed associate social worker licensed by the behavioral sciences regulatory board;
- (B) licensed clinical marriage and family therapist as defined in K.S.A. 65-6402, and amendments thereto;
- (C) licensed marriage and family therapist as defined in K.S.A. 65-6402, and amendments thereto:
- (D) licensed clinical professional counselor as defined in K.S.A. 65-5802, and amendments thereto;
- (E) licensed professional counselor as defined in K.S.A. 65-5802, and amendments thereto:
 - (F) licensed psychologist as defined in K.S.A. 65-6319, and amendments thereto;
- (G) licensed masters level psychologist as defined in K.S.A. 74-5362, and amendments thereto:
- (H) licensed clinical psychotherapist as defined in K.S.A. 74-5363, and amendments thereto; or
 - (I) a licensed child-placing agency.
 - (2) Any person performing an assessment pursuant to this subsection shall:
- (A) Possess a minimum of two years experience in adoption services or be supervised by a person with such experience; or
- (B) if licensed by the behavioral sciences regulatory board to diagnose and treat mental disorders in independent practice, possess a minimum of one year of experience in adoption services or be supervised by a person with such experience.";

Also on page 1, in line 32, by striking all after "no"; by striking all in line 33; in line 34, by striking all before "available" and inserting "one authorized pursuant to this section"; in line 40, by striking all after the second "the"; by striking all in line 41; in line 42, by striking "child placing agency" and inserting "person authorized pursuant to this section";

On page 2, in line 13, by striking "the social worker,"; by striking all in line 14 and inserting "any person authorized pursuant to this section to perform this assessment"; in line 19, by striking "a licensed social"; by striking all in lines 20 through 22 and inserting "a person authorized in that state to conduct such assessments. Such report shall be filed with the court not less than 10 days before the hearing on the petition."; in line 31, by striking "2006" and inserting "2007";

In the title, in line 10, by striking "2006" and inserting "2007"; and the bill be passed as amended.

Committee on **Judiciary** recommends **HB 2768** be amended on page 1, in line 15, before "Except" by inserting "(a)"; after line 23, by inserting the following:

"(b) A dead human body which is removed from the location of death shall be transported to a federally certified organ procurement organization serving the state of Kansas only upon the release of a person listed in the order of priority pursuant to K.S.A. 2007 Supp. 65-3228, and amendments thereto."; and the bill be passed as amended.

Committee on **Taxation** recommends ${\bf HB~2640}$ be amended by substituting a new bill to be designated as "Substitute for HOUSE BILL No. 2640," as follows:

"Substitute for HOUSE BILL No. 2640

By Committee on Taxation

"AN ACT concerning income taxation; relating to credits; capital investments in businesses located in certain cities damaged by a disaster; refunds."; and the substitute bill be passed.

(Sub. HB 2640 was thereupon introduced and read by title.)

Committee on **Transportation** recommends **HB 2824** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

Committee on **Transportation** recommends **HB 2770** be amended on page 1, in line 34, by striking "adopt rules and regulations"; by striking all in line 35 and inserting "prescribe a fee of \$12 and upon";

On page 5, in line 7, after "after" by inserting "January 1, 2009, and"; and the bill be passed as amended.

Committee on **Agriculture and Natural Resources Budget** recommends **SB 447** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

HB 2933, An act concerning sales taxation; relating to exemptions; Stella Wells Christmas Basket, inc.; amending K.S.A. 2007 Supp. 79-3606 and repealing the existing section, by Committee on Taxation.
