# INTRODUCTION OF GUESTS

Mr. Speaker and Fellow Members of the House of Representatives, I am privileged to stand here today with an incredible and impressive group of Kansas women. Before I tell you about the impressive accomplishment of this group I want to tell you what inspired their mission.

In July of 1999 Jamie and Brian Holeman had a prayer answered when they adopted a beautiful little girl they named Kassidy. Kassidy Holeman was a precious child that brought Mr. and Mrs. Holeman great amounts of joy and happiness. Sadly, the Holemans received tragic news in 2001 when doctors diagnosed little Kassidy with Leukemia. Kassidy proved to be a brave little girl and fought the disease with everything she had. However, God called little Kassidy home in July, 2006.

While hearts are broken over this loss and tears are still shed. Kassidy's parents have used this tragedy and the memory of little Kassidy as inspiration to not only to honor her, but to help countless other Kansans and Americans in the fight against Leukemia.

Last Spring, Jamie Holman, with the help of many close friends, organized Team Kassidy. Team Kassidy was a group of Wichita women who all agreed to help raise money for the Leukemia and Lymphoma Society. However, what they agreed and committed to do in order to raise the money is of special note. This extraordinary group of women made up wives, moms, and students agreed to enter the San Francisco Nike Women's Marathon.

Every member of Team Kassidy with us here today not only ran the marathon, they finished it. Perhaps even more remarkable than the completion of the marathon is the amount of money raised by Team Kasssidy. In all, women from all across America participating in the marathon raised an astounding \$18.8 million for the Leukemia and Lymphoma Society. Our team from Kansas, Team Kassidy made an impressive contribution to the cause in the amount of \$57,000.

## INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following concurrent resolution was introduced and read by title:

HOUSE CONCURRENT RESOLUTION No. 5038—

By Representative Myers

A CONCURRENT RESOLUTION establishing a Kansas energy plan.

WHEREAS, Energy plays a vital role in the Kansas economy; and

WHEREAS, Kansas needs an energy plan for the state to develop a balanced energy approach, a plan which allows for continued development of all energy sources but is not driven by special interests or energy crises; and

WHEREAS, According to data published by the Energy Information Administration, the state's total supply of electricity is nearly equal to the state's usage; and

WHEREAS, The State Corporation Commission reports in testimony on February 20, 2008, that due to the aging of much of the base power supply generation, it will be necessary to replace much of that generation within the next 20 years; and

WHEREAS, A state energy plan should provide a framework for future legislative action to move the state toward electric energy affordability, sustainability and independence: Now, therefore

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Legislature hereby establish the Kansas energy plan; and

Be it further resolved: That the following terms have the meanings provided below for purposes of the Kansas energy plan:

- (a) "Base-load generation" means dispatchable electric generation which is expected to be operated at a capacity factor greater than 45%, based on variable fuel costs. Base-load generation includes coal-fired steam, nuclear and hydropower generation.
- (b) "Capacity factor" means the amount of energy produced by a generator in a year divided by the product of the nameplate capacity rating of the generator times the number of hours in a year.
- (c) "Intermediate-load generation" means dispatchable electric generation which is expected to be operated at a capacity factor between 30% and 45%, based on variable fuel costs. Intermediate-load generation includes gas-fired combined cycle generation.
- (d) "Intermittent-load generation" means electric generation which has very low variable fuel costs and which cannot be dispatched because the output is controlled by the natural variability of the energy resource. Intermittent-load generation includes wind and solar energy generation.
- (e) "Nameplate capacity" means the rating in megawatts of an electric generator at 100% design conditions.
- (f) "Peak-load generation" means dispatchable electric generation which is expected to be operated at a capacity factor less than 30%, based on variable fuel costs. Peak-load generation includes combustion turbine, internal combustion engine and gas-fired steam generation; and

Be it further resolved: That the Legislature adopt the following policies as the foundation of the state energy plan:

- (a) Encouragement of continued development of alternative and renewable energy;
- (b) enactment of legislation implementing policies which will increase the electric transmission infrastructure of the state;
- (c) repeal of laws and public policies that restrict development of domestic energy supplies, including, but not limited to, nuclear power generation and domestic fossil fuel reserves:
- (d) support for the southwest power pool and the Kansas electric transmission authority in acquiring adequate transmission for electric generation needs of the state;
- (e) recognition that the age of the current electric generation capacity will require it to be replaced within the next 20 years; and
- (f) promotion of market driven solutions to electric generation needs of the state; and Be it further resolved: That the State Corporation Commission be requested to submit annually a written report to the senate committee on utilities and the house committee on energy and utilities, or their successors, on or before the beginning of the regular session of the Legislature beginning in 2009 on recommendations for legislative changes needed to facilitate the state energy plan, the development of clean burning coal technology and the progress of nuclear power generation in the country and state in particular; and

Be it further resolved: That the Legislature adopt the following for purposes of planning for future growth in demand for electricity:

- (a) For the year 2006, capacity available in this state from base-load generation was 43,584 gigawatt hours.
- (b) The total additional base-load generation capacity that will be needed in this state by the year 2028 is projected to be 59,000 gigawatt hours.
- (c) The projected increase in demand for electricity over the next 20 years will require the phase in of the following increases in electric generation capacity in this state:

- $(1)\;$  For the years 2007 through 2015, based on a historical annual growth rate of 1.3% per year, 4,416 gigawatt hours.
  - (2) Based on a projected annual growth rate of 1.6%:
  - (A) For the years 2016 through 2020, 4,000 gigawatt hours.
  - (B) For the years 2021 through 2025, 4,500 gigawatt hours.
  - (C) For the years 2026 through 2028, 2,500 gigawatt hours.
- (d) The state, in accordance with the policies expressed in section 3, and amendments thereto, shall take such actions as necessary to encourage the development of electric generation capacity in this state to meet increases in demand for electricity over the next 20 years; and

Be it further resolved: That the Legislature adopt the following for purposes of planning for future fuel needs for electric generation:

- (a) The present fuel mix for base-load generation in this state is coal, 73%; nuclear, 21%; and natural gas, 4%.
- (b) The state, in accordance with the policies expressed in section 3, and amendments thereto, shall take such actions as necessary to encourage the following fuel mixes to be the source of base-load electric generation in this state:
  - (1) By the year 2020, coal, 70%; nuclear, 25%; and natural gas, 5%.
  - (2) By the year 2025, coal, 65%; nuclear, 30%; and natural gas, 5%.
  - (3) By the year 2028, coal, 60%; nuclear, 35%; and natural gas, 5%.

The amount of credit allowed under this section shall be reduced by an amount equal to any assistance payment received by the taxpayer pursuant to the provisions of K.S.A. 75-3713e, and amendments thereto, or an assistance payment received by the taxpayer pursuant to the southeast Kansas business restoration assistance program as approved by the state finance council for the same investment as provided in this section. Notwithstanding any other provision of law, no taxpayer shall claim more than one credit allowed under this subsection for the same investment as provided in this section. If the amount of the tax credit determined under this section exceeds the income, privilege or premium tax liability for the taxpayer for any taxable year in which the qualified investment is made, the amount thereof which exceeds such tax liability may be carried over for deduction from such taxpayer's income, privilege or premium tax liability in the next succeeding year or years until the total amount of the credit has been deducted from tax liability, except that no such credit shall be carried over for deduction after the 10th taxable year succeeding the taxable vear in which the qualified investment was made.

- (b) (1) For tax years 2007, 2008, 2009 and 2010, a taxpayer may receive a refund of tax liability in lieu of the credit provided in this act. The refund shall be in an amount up to 50% of the credit earned by the taxpayer. The amount of refund allowed under this subsection shall be reduced by an amount equal to any assistance payment received by the taxpayer pursuant to the provisions of K.S.A. 75-3713e, and amendments thereto, or an assistance payment received by the taxpayer pursuant to the southeast Kansas business restoration assistance program as approved by the state finance council for the same investment as provided in this section. Notwithstanding any other provision of law, no taxpayer shall claim more than one credit or refund allowed under this subsection for the same investment.
- (2) A claim for refund shall be made prior to the taxpayer claiming any credit on which the refund is based. Should the taxpayer elect to receive the cash in lieu of the credit, the remaining portion of the tax credit shall be lost. Any refund pursuant to this subsection shall be allowed against the tax liability imposed under the Kansas income tax act, the premium tax or privilege fees imposed pursuant to K.S.A. 40-252, and amendments thereto, and the privilege tax as measured by net income of financial institutions imposed pursuant to article 11 of chapter 79 of the Kansas Statutes Annotated in the tax year the qualified investment is placed into service. When a person shall contract for the construction, reconstruction, enlargement or remodeling of any such business facility, such person shall obtain from the state prior to July 1, 2009, an exemption certificate for the project involved. The certificate shall be furnished to the contractor to purchase materials, machinery and equipment for incorporation in such project. The contractor shall furnish the number of such certificates to all suppliers from whom such purchases are made, and such suppliers shall execute invoices covering the same bearing the number of such certificate. Upon completion of the project the contractor shall furnish to the person that obtained the exemption certificate, a sworn statement, on a form to be provided by the director of taxation, that all purchases so made were entitled to exemption under this subsection. All invoices shall be held by the contractor for a period of five years and shall be subject to audit by the director of taxation. Any contractor or any agent, employee or subcontractor thereof, who shall use or otherwise dispose of any materials, machinery or equipment purchased under such a certificate for any purpose other than that for which such a certificate is issued without the payment of the sales or compensating tax otherwise imposed thereon, shall be guilty of a misdemeanor and, upon conviction therefor, shall be subject to the penalties provided for in subsection (g) of K.S.A. 79-3615, and amendments thereto.
