The House met session pro forma with Speaker pro tem Dahl in the chair.

## INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bill was introduced and read by title:

**HB 2983**, An act establishing the physician work force and accreditation task force; providing for the composition and the duties and functions of the task force; report to the 2009 session of the legislature, by Committee on Appropriations.

## REPORTS OF STANDING COMMITTEES

Committee on **Appropriations** recommends **HB 2890**, as amended by House Committee, be amended as recommended by the General Government Budget Committee and the bill, as printed with amendments by House Committee, be further amended:

On page 3, in line 16, by striking "Five" and inserting "Four"; and the bill be passed as amended.

Committee on **Appropriations** recommends **SB 534** be amended on page 1, in line 18, by striking "year ending June 30, 2008," and inserting "years ending June 30, 2008, June 30, 2009, June 30, 2010, June 30, 2011, and June 30, 2012,";

On page 9, by striking all in lines 35 through 43;

And by renumbering sections accordingly;

On page 10, in line 29, by striking "Provided" and inserting "*Provided further*, That the state board of regents and any such institution shall not charge Brittany Jordan for books, fees or tuition at such institution subject to the provisions of this subsection: *And provided*"; in line 40, before "any" by inserting "the director of accounts and reports shall transfer the amount of"; in line 41, by striking "is hereby lapsed" and inserting " to the state general fund"; by striking all in lines 42 and 43;

On page 11, by striking all in lines 1 and 2, and inserting the following:

"(d) On the effective date of this act, the special tuition reimbursement fund is hereby created in the state treasury and the secretary of social and rehabilitation services shall certify to the director of accounts and reports the amount or amounts to be transferred, which in

the aggregate shall be equal to \$23,320, from moneys appropriated in one or more accounts of the state general fund or any special revenue fund or funds of the department of social and rehabilitation services to the special tuition reimbursement fund. Upon receipt of such certification, the director of accounts and reports shall transfer the amount or amounts specified in such certification from the account or accounts of the state general fund and the special revenue fund or funds to the special tuition reimbursement fund, as specified in such certification. At the same time that such certification is transmitted to the director of accounts and reports, the secretary of social and rehabilitation services shall transmit a copy of such certification to the director of the budget and the director of legislative research.”;

And the bill be passed as amended.

Committee on **Insurance and Financial Institutions** recommends **SB 465** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.
