## EIGHTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Thursday, January 24, 2008—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-eight senators present. Senators Emler and Lee were excused. Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

You know that I am not permitted to lobby in my prayers for issues facing, or likely to face, the Senate. I have no problem with that because Senators would have no opportunity to debate me publicly like they debate each other.

But, as You also know, I sometimes consider myself a lobbyist for the Senators. From time to time political observers seem to expect a bipartisan vote on every issue . . . including those which are highly controversial.

On critical issues I'm sure You are saddened when any of us makes the wrong decision. Forgive me if I'm being presumptuous, but I believe that You believe it's better than one person having the authority to make all decisions.

**SB** 464, An act concerning insurance; relating to waiving certain requirements regarding reinsurance agreements when an insurance company ceases to do business; amending K.S.A.

 $2007\ {\rm Supp.}\ 40\text{-}5201$  and 40-5210 and repealing the existing sections, by Committee on Financial Institutions and Insurance.

**SB** 465, An act concerning insurance companies; relating to certain requirements regarding filing rates and forms; amending K.S.A. 2007 Supp. 40-216 and repealing the existing section, by Committee on Financial Institutions and Insurance.

SB~466, An act concerning the minimum wage and maximum hours law; amending K.S.A. 44-1203 and repealing the existing section, by Senator Reitz.

**SB** 467, An act relating to manufactured housing; concerning the filing of notice of security interest; amending K.S.A. 2007 Supp. 58-4204 and repealing the existing section, by Committee on Judiciary.

SB 468, An act concerning telecommunications; relating to the federal universal service fund and certification of federal high cost support by the state corporation commission; amending K.S.A. 66-2001 and 66-2002 and repealing the existing sections, by Special Committee on Energy, Natural Resources and Environment.

**SB** 469, An act concerning telecommunications; relating to local exchange carriers and carriers of last resort; amending K.S.A. 66-2009 and repealing the existing section, by Committee on Utilities.

SB 470, An act concerning school districts; relating to school safety violations; amending K.S.A. 2007 Supp. 72-89c02 and repealing the existing section, by Senator V. Schmidt.

**SB 471**, An act concerning taxation; relating to electronic filling of returns and reports; amending K.S.A. 79-3220 and K.S.A. 2007 Supp. 75-5151 and repealing the existing sections, by Committee on Assessment and Taxation.

SENATE RESOLUTION No. 1804-

WHEREAS, The regional winners of the 2008 "If I Were Mayor" youth essay contest are: Emma Barnett (south central regional winner) who attends Hutchinson Middle School; David Crawford (north central regional winner) who attends Ruppenthal Middle School in Russell; Shelby Gardner (northwest regional winner) who attends Colby Middle School; Mariza Hernandez (northeast regional winner) who attends Resurrection School at the Cathedral in Kansas City; and Brad Stevens (southeast regional winner) who attends Augusta Middle School: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend the six regional winners of the 2008 "If I Were Mayor" youth essay contest and statewide winner Nicole Brauer.
