STATE AFFAIRS COMMITTEE

January 29, 1962

The meeting was called to order by the Chairman and Mr. Fribley was asked to discuss Senate Bill 19. Mr. Fribley stated that this was a measure to take care of something forgotten at the last session; i.e. to establish a revolving fee fund for the purpose of collecting from the sale of meals, etc. from visitors and employees at the diagnostic center. He states that this will be exactly like the funds already established at all the other institutions. Further, it seeks to remove the limitation on residency requirements for the superintendent, otherwise we would not necessarily be able to secure the proper personnel.

Various members of the committee made inquiry as to the intent and impact of the measure, and after considerable discussion it was moved by Mr. Ford and seconded by Miss Jacquart that Senate Bill 19 be passed out favorably. Upon vote, motion carried unanimously.

Thereupon, Mr. Fribley discussed Senate Bill No. 20, which is a measure to make the appropriation for the revolving fund mentioned in Senate Bill 19; that the only change in Section 76-2601 of the General Statutes, is the addition of "Kansas state reception and diagnostic center, \$1,000"; that the other appropriations have nothing to do with State Affairs Committee, and the bill was sent to us only because the bill establishing the Center came through the Committee last year.

It was moved by Mr. Gardner and seconded by Mr. Johnson that this measure be recommended favorably. Upon vote, motion carried unanimously.

The Chairman announced that another meeting would be held on January 30th to consider HCR 20 and Senate Bills 21 and 28.

Meeting was adjourned.

SENATE BILL No. 20

AN ACT providing for a revolving fund for the Kansas state reception and diagnostic center and making an appropriation thereto; amending section 76-2601 of the General Statutes Supplement of 1961, and repealing said original section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. Section 76-2601 of the General Statutes Supple-2 ment of 1961 is hereby amended to read as follows: Sec. 76-3 2601. The following revolving funds now in existence are 4 hereby declared to be permanent and the following revolving 5 funds which are not now in existence are hereby established; 6 and shall remain in the hands of the officers of the following 7 spending agencies in the amounts herein set out to be used 8 as provided by law:

- SEC. 2. There is hereby appropriated out of the state gen-2 eral revenue fund for the fiscal year ending June 30, 1962, the 3 sum of one thousand dollars (\$1,000) to the Kansas state recep-4 tion and diagnostic center revolving fund to provide for the 5 fund authorized in section 1 of this act. Such fund is hereby 6 appropriated for the uses and purposes provided in section 76-7 2604 of the General Statutes Supplement of 1961 for the fiscal 8 year 1962.
- Sec. 3. Section 76-2601 of the General Statutes Supple-2 ment of 1961 is hereby repealed.
- Sec. 4. This act shall take effect and be in force from and 2 after its publication in the statute book.

SENATE BILL No. 19

By Committee on Ways and Means

AN ACT relating to the Kansas state reception and diagnostic center; providing for the diagnostic center fee fund, and making appropriations of moneys in such fund; amending section 76-24a05 of the General Statutes Supplement of 1961, and repealing said original section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. Section 76-24a05 of the General Statutes Supple-

- 2 ment of 1961 is hereby amended to read as follows: Sec. 76-
- 3 24a05. The director shall appoint a superintendent of the
- 4 center, who shall be within the classified service under the
- 5 Kansas civil service act, but the residence requirements of said
- 6 act shall not apply to such appointment. The superintendent
- 7 shall pay monthly to the state treasurer all moneys that may
- 8 come into his hands from sales of meals to employees, rentals
- 9 of property, and all other sources, except as may otherwise be
- 10 provided by law, and the state treasurer shall credit the same
- 11 to the diagnostic center fee fund, which fund is hereby created.
- 12 The superintendent shall submit to the director and the state
- 13 controller an itemized and verified statement of all moneys
- 14 received and paid into the state treasury, and all such moneys
- 15 are hereby appropriated for the general maintenance purposes
- 16 of said institution.
 - Sec. 2. Section 76-24a05 of the General Statutes Supple-2 ment of 1961 is hereby repealed.
 - Sec. 3. This act shall take effect and be in force from and 2 after its publication in the official state paper.
