House Judiciary Committee Meeting Monday, April 1, 1963

The House Judiciary Committee met Monday, April 1, 1963, in Room 523 at 4:45 P.M. with Chairman Clyde Hill presiding. Fourteen members were present. Members Briggs, Davis, Euler, Tillotson, Van Cleave and Williams were absent. Frank Muerer, Vice President of Vernon Law Book Company; Victor Holper, Vice President and Editor in Chief of West Publishing Company, and Franklin Corrick, Revisor of Statutes were present to speak concerning Senate Bill No. 366.

Chairman Hill called the meeting to order.

Frank Muerer, Victor Holper and Franklin Corrick spoke briefly concerning Senate Bill No. 366, an act relating to the compiling, annotating, indexing, printing, binding, sale and distribution of the Kansas statutes annotated, the supplementation thereof; and prescribing certain powers and duties in connection therewith, amending sections 77-304 and 77-306 of the General Statutes Supplement of 1961 and section 77-305 of the General Statutes of 1949, and repealing said original sections.

Mr. Corrick stated that there would be an additional cost of \$36,675 for the index that the Senate amended in the bill.

Chairman Hill said that as he understands it, the matters to be included in the index would be under the direction of Mr. Corrick. Mr. Corrick stated that this is correct.

Mr. Holper outlined very briefly what would be included in this revision. He stated that the work will be done in St. Paul, Minnesota. Mr. Holper pointed out that there are over one hundred lawyers on their staff and the people doing the work are very experienced.

Chairman Hill thanked the gentlemen for appearing.

The House Judiciary Committee met Monday, April 1, 1963, in Room 529 at 7:00 P.M. with Chairman Clyde Hill presiding.

The members of the committee heard the opponents of Senate Bill No. 137, an act prohibiting the sale or offering for sale on the first day of the week, commonly called Sunday, or the compelling, forcing or obligating of employees to sell certain named items on said day; providing certain exemptions; prescribing penalties for violations; and repealing sections 21-952, 21-953, 21-955 and 21-956 of the General Statutes of 1949.

Speaking in opposition to Senate Bill No. 137 were Blake Williamson, a Kansas City, Kansas, attorney and former state representative; Dick Roach, a Topeka hardware merchant; James Pratt, an owner of the Shoppers' City building, and Louis Pozez, president of Shoppers' City.

The members of the committee also heard speakers concerning Senate Bill No. 276, an act relating to workmen's compensation; and pertaining to the amount of compensation; amending section 44-510 of the General Statutes Supplement of 1961, and repealing said original section.

No action was taken by the committee.
