Thereupon, Senator Sanborn moved, seconded by Senator Glades, that new chairs be purchased for the secretaries of the Senate, and the wooden chairs presently in use be refinished for use in the gallery, as follows:

Senator Ralph L. Davison, chairman of the Senate Claims and Accounts Committee, appeared with reference to Senate Bill No. 315. He stated the total amount allowed is \$8,647.80; of which \$2,980.74 are workmen's compensation claims. Asked if the claims should be paid from current operating budgets of the institutions involved or from general revenue funds, he stated that is a determination of this committee.
