SENATE WAYS AND MEANS COMMITTEE

Minutes of the Meeting April 10, 1963

The meeting was called to order at 3:10 p.m., April 10, 1963, by Chairman Smith, with all members present.

Mr. James Bibb, Budget Director, indicated that it is necessary to include as line items in the omnibus bill no limit appropriations to the Kansas State University and the University of Kansas for special revenue fund expenditures in connection with research foundation programs. Senator Hults moved that the omnibus bill include these as line items. Senator Harper seconded the motion. Motion carried.

With reference to the Adjutant General's request for permission to lease an airplane for executive use, Senator Van Sickle moved that in lieu of such an appropriation, that the Department of Administration be requested to study the feasibility and possibilities of providing executive-type aircraft for the executive departments of the State and/or the leasing or chartering of such aircraft for these uses.

Senator Glades made a substitute motion that \$10,000 be included in the omnibus bill to be used by the Governor for air travel as needed. Senator Farmer seconded the motion. Motion carried.

Senator Van Sickle renewed his motion that the Department of Administration make a study of the possibilities of providing air transportation. Senator Harper seconded the motion. Motion carried.

The Budget Director also noted that an appropriation to the Park Authority is necessary to implement the stamp-sticker program for park use permits as enacted in Senate Bill No. 316. Senator Van Sickle moved that the committee approve an appropriation in the amount of \$9,954 (\$5,968 salary, \$2,000 automobile, and \$1,986 office supplies) for administration of the stamp-sticker program in the State parks.

Senator Harper made a substitute motion that the committee approve the House amendment to the bill. Senator Glades seconded the motion. The motion failed.

Thereupon, Senator Van Sickle renewed his motion, and Senator Sanborn seconded it. The motion carried.

The meeting recessed at 3:40 p.m.

Senate Ways and Means Committee Minutes, April 10, 1963 - 2

The meeting reconvened at 11:40 p.m., April 10.

It was moved by Senator Ward, seconded by Senator Sanborn, that House Bill No. 463 be amended by deleting original Section 54, now Section 56, and by renumbering the subsequent sections. The motion carried with three dissenting votes: Senators Farmer, Harper, and Warren.

Senator Glades moved that the Education Committee be notified of the action taken by the committee in deleting Section 54. Senator Harper seconded the motion. The motion failed.

Senator Harper moved, seconded by Senator Hults, that the committee delete the House amendment to Section 10, Line 3, concerning the salary of the director of the Research Department of the Legislative Council. The motion carried. (See Attachment No. 1.)
