SENATE WAYS AND MEANS COMMITTEE

Minutes of the Meeting February 7, 1964

The meeting was called to order by Chairman Smith at 9:00 a.m. on February 7, 1964. All members were present.

Senator Sebelius explained the items approved by the Committee on Claims and Accounts as presented in Senate Bill 31 to be introduced and referred to the Committee. It was moved by Senator Farmer and seconded by Senator Saar that SENATE BILL 31 be recommended for passage. The motion carried.

Senator Van Sickle presented the subcommittee report on the budget for the Board of Cosmetology as contained in House Bill 14, section 9 and House Bill 21, section 12, with the recommendation that these sections be amended. (See Att. 1) It was moved by Senator Van Sickle and seconded by Senator Saar that section 9, HOUSE BILL 14 and section 12, HOUSE BILL 21 be amended in accordance with the subcommittee report. The motion carried.

As no amendments were recommended by the subcommittees reporting on the sections of HOUSE BILL 12, Senator Farmer made the motion which was seconded by Senator Hults that House Bill 12 be recommended for passage. The motion carried.

Senator Harper presented information regarding a supplemental appropriation of \$95,540 for the Revisor of Statutes over the budget contained in Section 4 of House Bill 9. The supplemental appropriation was necessary to pay for a revised estimate of cost of indexing the new Annotated Statutes, based on information which came to the Revisor after the budget was approved by the House of Representatives. Senator Harper and Senator Smith pointed out that had this information been available to the House Ways and Means Committee they would have made the addition in the bill.

For the above reason, it was moved by Senator Harper and seconded by Senator Jones that the supplemental appropriation for the Revisor of Statutes be made a part of the Omnibus Bill. The motion carried.

As there were no other amendments offered on House Bill 9 by any of the reporting subcommittees, it was moved by Senator Hults and seconded by Senator Farmer that HOUSE BILL 9 be recommended for passage. The motion carried.

As there were no further amendments offered on House Bill 14 by any of the reporting subcommittees, it was moved by Senator Jones and seconded by Senator Sanborn that HOUSE BILL 14 be recommended for passage as amended in section 9. The motion carried.

It was moved by Senator Sanborn and seconded by Senator Van Sickle that section 14 of House Bill 21 be amended by changing the figure "38" to "39" as it was a typographical error. The motion carried.

Senate Ways and Means Committee - Minutes of the Meeting February 7, 1964

As no further amendments were offered to House Bill 21 by any of the reporting subcommittees, it was moved by Senator Van Sickle and seconded by Senator Sanborn that HOUSE BILL 21 be recommended for passage as amended in section 12 and section 14. The motion carried. (See Att. 5)

No amendments were recommended by any of the subcommittees reporting on the sections of House Bill 22 which has been referred to the committee for recommendation. Senator Hults stated that in regard to a motion passed by the committee directing Wayne Richey to look into some way to restrict the Department of Social Welfare to have their data processing work done by the Department of Revenue, he had talked with Mr. Bibb who had assured him that it was within his authority to see to it that this work would be done by the Department of Revenue. Therefore, an amendment to the budget of the Department of Social Welfare as contained in House Bill 22 was unnecessary.

It was moved by Senator Sanborn and seconded by Senator Jones that HOUSE BILL 22 be recommended for passage. The motion carried. (Att. 6)
